# Grand Mufti of the Kingdom of Saudi Arabia receives the Secretary General of the Academy in Riyadh

H.E. Sheikh Abdul Aziz bin Abdullah Al-Sheikh, Grand Mufti of the Kingdom of Saudi Arabia, President of the Council of Senior Scholars and Head of the General Presidency of Research and Ifta, received on Thursday 29 Jumada Al-Akhira 1442, corresponding to 11 February 2021 in his office in Riyadh, H.E. Prof. Koutoub Mustapha Sano, Secretary General of the Academy.

The Grand Mufti welcomed and thanked his guest and the accompanying delegation for their visit. His Excellency took this opportunity to congratulate the Secretary General on his appointment to the Academy.

The Secretary General of the Academy then made a detailed presentation on the message, values, objectives and the most important



activities and programs that the world and providing appropriate Academy undertakes inside and outside the Muslim world, in addition to the critical role entrusted to it by Muslim world leaders, its peoples and Muslim communities. This can be summed up in clarifying Shariah resolutions on issues of concern to Muslims around the

Shariah solutions to the problems of contemporary life, as well as addressing the provisions of the true Islamic law regarding issues and current developments, based on the Holy Book of Allah, the Noble Sunnah of the Prophet and the rich Islamic heritage.

His Excellency concluded his presentation by informing the Grand Mufti that the Academy has developed a five-year strategic plan to achieve its objectives, particularly with regard to strengthening cooperation, coordination and integration between the Academy and the leading Shariah institutions in the Muslim world in general and the headquarters country in particular.

To achieve this, the Academy vows to sign a cooperation agreement and a memorandum of understanding with the General Presidency of Research and Ifta and the Council of Senior Scholars, which includes eminent and distinguished scholars.

On his part, the Grand Mufti expressed his satisfaction with the additional information he had re-



ceived about the Academy, reiterated his thanks to His Excellency for his visit and assured him of the cooperation between the Academy, the Council of Senior Scholars and the General Presidency of Research and Ifta, asking Allah to grant success and reward to the Secretary General of the Academy.

At the end of the meeting, the Grand Mufti presented a commemorative gift to the Secretary General of the Academy who in return presented him with a copy of the fourth edition of the Academy's resolutions and recommen-

#### The Secretariat General of the Academy calls for the permissibility of using the Covid-19 vaccines, and the permissibility of using the Zakat funds to purchase vaccines

In response to two inquiries from the Secretariat General of the Organization of Islamic Cooperation and the Islamic Development Bank about the Shariah ruling on the use of new vaccines against Covid-19, and about the Sharia's ruling on disbursing zakat funds to buy vaccines and finance their distribution to the poor, the General Secretariat of the International Islamic Figh Academy held on Monday the 10 of Rajab 1442, corresponding to 22 February 2021, a medical jurisprudential seminar to answer the above inquiries under:

"The Medical Fiqh Symposium on the Shariah rulings regarding the Use of the new Covid-19 vaccines and financing its distribution through Zakat funds for the

1) The Fiqh symposium concluded after discussions and deliberations between the virtuous jurists and doctors that the use of the current vaccines against Covid-19 is permissible in Islam, and their use becomes obligatory upon everyone if the authorities oblige to do so thus Muslims are obliged to be respectful and obedient to the instructions of their authorities especially with regard to issues related to the public interest particularly the protection of the life.

Accordingly, the seminar called on Muslims around the world to abide by the instructions issued by the public health authorities in their communities in order to safeguard their lives and the lives of others. 2) As for the disbursement of zakat funds



to buy vaccines and finance their distribution to the poor people and nations, the seminar decided that \*this is legally permissible to do so. This is due to the fact that the pandemic of the emerging corona virus (Covid 19) is a global danger that threatens all humanity. Therefore it must be combated with all permissible material and moral means. The portion of the zakat that should be utilized is under the recipient called "for the sake of God". The share of this recipient could be used to buy vaccines and finance their distribution to the poor. The seminar called on scholars, preachers, imams and guides to direct people to respond to vaccination campaigns, and to warn against rumors and fatwas that raise confusion about the legality of using the new vaccines, and also called on rich countries to cooperate to provide vaccines to countries which are unable to purchase them and finance their distribution.

The seminar was chaired by His Excellency Sheikh Dr. Saleh bin Abdullah bin Humaid, a member of the Senior Scholars Council, the imam and preacher of the Grand Mosque, the president of the Academy, and the discussions and deliberations were moderated by His Excellency Prof. Dr. Koutoub Moustapha Sano, Secretary General of the Academy, and a blessed elite of eminence, Excellencies, senior male and female scholars, members, experts of the Academy, as well as the distinguished physicians attended the seminar.


enable the Academy to achieve its objectives and carry out its mission to the best of its ability

# Kuwait Center for Islamic Economy invites Prof. Sano to deliver a lecture on "Methodology of Writing Scientific Thesis in Islamic Economics"



Following the invitation of the Kuwait Center for Islamic Economy at the Ministry of Awqaf and Islamic Affairs of the State of Kuwait, H.E. Prof. Koutoub Sano, Secretary General of the Academy, gave a public lecture on Monday 15 February 2021, within the framework of the center's activities. More than six hundred and fifty people attended the online lecture entitled "Methodology of Writing Scientific Thesis in Islamic Economics".

His Excellency started his lecture with a scientific review on the leading position of Islamic economics at the present day, as the Islamic economic theory is nowadays studied side by side with traditional economic theories. Hence a tremendous interest is growing in Islamic economic thought in general, and in Islamic finance in particular, as evidenced by the wide spread of Islamic banks and financial institutions throughout the world.

In his lecture, His Excellency referred to the need to give an important place to scientific research in Islamic economics in response to developments in the contemporary economic arena at all levels and to keep pace with the changes taking place in financial and business matters. He also discussed in detail the most essential and necessary scientific criteria in writing scientific theses. These criteria are represented in the statement on

the importance of the research topic, the formulation of the research question in the form of precise methodological questions, the determination of the research objectives that represent answers to the questions, scientific and objective review of past literature to highlight the aspects not covered hitherto, editing the study chapters in the light of the objectives. His Excellency also stressed the importance of balancing the study chapters by early sizing (determining a balanced size) of their pages so that one chapter does not overwhelm another.

Furthermore, His Excellency referred to the importance of the evaluation of academic theses and called on their chairmen and supervisors to motivate the young generation to take an interest in Islamic economics and to help them conduct their research in a flexible and accessible manner. He also called on researchers and students to pay attention to the scientific subjects of Islamic economics that had not received as much scientific research as needed, such as the subjects of wills, vows, financial compensation, etc., and how to benefit from them in the field of finance, which is known as social finance.

His Excellency concluded his lecture by expressing his thanks and appreciation to the Kuwait Center for Islamic Economy for its sponsorship of research, science, and training in the field of Islamic economy.

# Final Statement and Recommendations of the Medical Figh Symposium:

# Shariah Rulings regarding the Use of Covid-19 Vaccines, their Purchase and the Financing of their Distribution with Zakat funds



First: Final Statement

Praise to Allah Lord of the worlds, and may the blessings and peace be upon whom He sent as a mercv. our master Muhammad, upon his family, companions, and those who follow them until the Day of Judgment

With the grace of Allah, the Secretariat General of the International Islamic Figh Academy of the Organization of Islamic Cooperation (Jeddah, Kingdom of Saudi Arabia) held via videoconference on Monday 10 Rajab 1442 (22 February 2021) a medical fiqh symposium on Shariah rulings regarding the use of Covid-19 vaccines, the purchase of these vaccines and the financing of their distribution with Zakat funds, following two questions received from the OIC Secretariat General and the Islamic Development Bank.

The symposium brought together several eminent scholars who are also members and experts of the Academy (list of names attached), and opened with a recitation of the Holy Quran.

H.E. Sheikh Saleh bin Abdullah bin Humaid, President of the Academy and Advisor to the Royal Saudi Court, delivered the opening address in which he welcomed the distinguished participants and thanked them for accepting the invitation of the Secretariat General of the Academy to participate in the medical figh symposium.

Afterwards, H.E. Prof. Koutoub Moustapha Sano, Secretary General of the Academy, presented in the keynote address the first question of the Secretariat General of the Organization of Islamic Cooperation, and the second question of the Islamic Development Bank, which both read:

1) What is the Shariah ruling on the use of Covid-19 vaccines?

2) What is the Shariah ruling on the purchase of Covid-19 vaccines and the financing of their distribution to the poor using Zakat funds? After presenting the two questions to the jurisconsults and doctors, the seminar's audience listened to a detailed presentation of the participating doctors who gave essential explanations on the most important substances that make up the currently available vaccines against Covid-19 from a medical point of view. Then the audience listened to the interventions of the jurisconsults on the questions mentioned above. A committee was therefore formed among the symposium participants to formulate its recommendations. The Secretariat General of the Academy contacted the participating jurisconsults and doctors in order to submit their proposals on the recommendations. The Academy received many interesting proposals, and after review, the following recommenda-

tions were concluded: Second

Recommendations

1) Components of Current Covid-19 Vaccines

Specialists in pharmacology and preventive medicine confirm that the vaccines available against Covid-19 consist of the messenger RNA (ribonucleic acid) of the "SARS CoV2" virus, recombinant DNA material, the common cold virus (adenovirus), other viruses, bacteria, compounds of quillaja tree and plants (as bioreactors), in addition to other auxiliary substances such as potassium, sodium, magnesium, phosphate, acetic acid, tromethamine hydrochloride, diacetate, polysorbate, sucrose, lipids, cholesterol, histidine, ethanol and

Therefore, these vaccines do not contain pig or human derivatives, and during their production, chemical reactions and transformations occur between their components, which fall within the Shariah rulings regarding metamorphosis in Islamic jurisprudence.

2) Shariah Ruling on the Use of Current Vaccines

Based on the above medical description of the current vaccines, their use for vaccination against Covid-19 is permissible according to Sharia law.

Moreover, vaccination becomes mandatory if the government obligates it, because the government's rulings are commended by upholding public interests.

On this basis, this symposium calls on Muslims around the world to comply with the instructions issued by the governments of their countries and by the competent health authorities in their communities, in order to implement the Shariah objective of the preservation of life, which is one of the necessary purposes in Islamic law.

3) Shariah Ruling on the Use of Zakat funds for the purchase of Covid-19 Vaccines

After examination and review of the Shariah-based evidences, the supreme purposes, the general maxims, the finalities of actions, the jurisprudential efforts (Ijtihad) of the renowned jurisconsults, past and present, on the meanings of the eight categories of the Zakat recipients mentioned in the Qura-

nic verse: "Zakat expenditures are only for the poor and for the needy and for those employed to collect [zakat] and for bringing hearts together [for Islam] and for freeing captives [or slaves] and for those in debt and for the cause of Allah and for the [stranded] traveler an obligation [imposed] by Allah. And Allah is Knowing and Wise." Al-Tawbah 60.

The symposium recommends the following:

(A) It is permissible to use Zakat funds as this is contained in the above category of "and in the cause of Allah"; as a matter of fact, the Covid-19 pandemic threatens all humanity, and it must be fought with all the scientific and material means that are permitted. Therefore, the ruler (government) has the right to use the Zakat funds for the elimination of this danger.

(B) To say: it is legitimate under Sharia law to use Zakat funds to purchase vaccines and finance their distribution, does not allude to spending all Zakat funds for that purpose. Indeed, only a part of its funds would be spent for that while taking into account the rest of the beneficiaries based on the evaluation of interests and needs.

4) General Recommendations

1- Calling on the states of the world, especially those that are able to cooperate in making vaccines available to countries that cannot purchase them, to finance their distribution to the needy people of the world, because the fight against Covid-19 must be global and for all the countries of the world so that everyone will be protected against the pandemic, in sha Allah. 2- Calling on states, organizations, health authorities, media and all humanity to consider vaccination as a humanitarian issue, which requires cooperation and solidarity in vaccines distribution between countries and humans in a simple and accessible manner.

3- Calling on scholars, preachers, imams, orators and counsellors to advise people to respond favorably to the Covid-19 vaccination campaigns and to warn against rumours and irregular fatwas that sow confusion about the legitimacy of the use of these vaccines, which have been medically proven to be effective and capable of protecting humans against this pandemic.

4- Calling on Muslims to return to Allah, to repent even more, to seek for forgiveness, to give more charities and acts of obedience, so that Allah may spare this pandemic from us and the world, and may He accept those who have perished because of this pandemic. May Allah grant them His forgiveness and mercy, and may He hasten the healing of the sick, protect us and all mankind, for He is All-Capable. We ask Allah to hasten the end of this pandemic and may wellness, security, and peace prevail over all peoples. May the blessings and peace of Allah be upon our prophet Muhammad, his family and all his companions.



Indeed it is the norm of life, and the law of the universe, that we sometimes wake up to hear news that could tear the eyes, sadden the heart, confuse the mind, and affect the soul.

Last Monday, February 8th was a very difficult and trying day for me, as the news of the passing of our beloved father, Professor Malik Badri, was announced. Yet, it was the most challenging hour that I have had in recent years. This is due to the fact that he was for me as for many students a source of inspiration and guidance. He was a model of pious and truthfulness. A scholar who worshiped his Lord day and night, his tongue never tired of performing supplications and prayers.. O The Almighty..

Is this true that the angel of death stretched out his hand to the soul of our father, our teacher, our educator and the educator of generations..

Is this true that our father will no longer answer our calls, our messages..

Is this true that this great erudite of Allah will not be able, from now onwards, to guide us out of our worries and distress

Is this true that the interpreter of our dreams and the analyst of our behavior will no longer be there to council us

Is this true that from today onwards we will be deprived of enjoying and savoring our father's prayers and

Indeed, our Lord... all this is true... death is true... the day of judgement is true... the resurrection is true... Paradise is true... Hell is true... but we are desperately troubled and deeply triste by his demise..

Yes, we do strongly believe that he deserves the mercy and forgiveness of The All Forgiving in shaa Allah.. He has been for me and for many generations a spiritual father, a great educator, a pride for the Islamic Ummah, and an excellent reference for Muslim and non-Muslim psychologists.

Truly, he left our mortal world after being ears and sight for thousands of those who sought a rational Islamic interpretation of dreams and a coherent scientific analysis of human behavior based on the Noble Book of Allah and the Sunnah of His Messenger (PBUH). As believers we certainly accept the fact that he responded the call of the Creator of the Universe after serving his Lord, his Prophet (PBUH) and his Ummah

as well as fulfilling his duty on earth.

Yes he would always be remembered as a righteous scholar and a devoted worshipper, whose light shone on his forehead, whose tranquility was above his life, whose trust in Allah filled his wings, whose optimism never left his tongue, the tragedies of this age never

affected him, harsh circumstances never changed his positions; the delations of the enemies did not bother him and did not change his fatherly love to us.. For decades we used to see him always smiling in front of crises, his heart was open to ease the dark situations and harsh circumstances..

He was constantly reminding us day and night of the power of dhikr (divine invocations), and of dua (supplications) to overcome obstacles and difficulties..

For decades he never tired of leading, counseling and guiding us. Meeting him was a source of comfort to our souls, and hearing his voice was a source of hope and courage.

O Allah.. You are our witness that much of our worries would disappear when we met him, and a cloud of our anguish would disperse as we listened to his speeches.. He taught us that adulation and flattery are among bad manners and that honesty, integrity and courtesy in words and behaviour are honorable people's qualities.. Indeed, he was deep in his observations, creative in his analyses, exceptional in his interpretations of dreams, continually seeking to solve his students' problems. He was also so attached to the Mosque, always invoking Allah, and carrying in his retreats a fragrant purple rosary, that smelled sincerity.

We have learned from this great teacher of generations that our Islamic heritage is wealthy with the knowledge and ideas of great psychologists, and that this heritage includes psychological interpretations and analyses that are no less consistent, profound and mature than what others boast of in this era.

He – may Allah have mercy on him – has always told us in conferences and meetings that there are genuine efforts in the field of psychological and behavioral studies among such virtuous scholars such as Al-Ghazali, Ibn Rochd, Ibn Sina, Ibn Taymiyya, Ibn Al-Qayyim, Ibn Sirin, among others who deserve the pride and praise of the Muslim Ummah.

May Allah have mercy on you, and reward you with the best of rewards, in my name and that of all your students, all your disciples, and all those who love science, purification, and education..

May Allah accept you alongside the Prophet (PBUH) whom you truly loved and whom you had sincerely invoked in your movements and gestures.

My family and I express our condolences to the students of knowledge that you were sincerely devoted to their education, and you taught them self-confidence and pride in their heritage and culture.



Furthermore, His Excellency stressed that the estimated financial budget for the implementation of the strategic plan represents both a great challenge and a great opportunity; and it should in no way be an obstacle and obsession, for after seeking help and trusting in Allah the Almighty, we must seek sponsors and conclude partnership agreements with donors

inside and outside the Muslim world in order to mobilize the greatest possible support and spread the financial burden over several sources.

His Excellency then addressed the agenda of the meeting, speaking with colleagues, each in their field of expertise. The meeting resulted in several administrative decisions, notably:

• To distribute the new administrative offices among the divisions according to the needs of each division.

• To pay the overtime bonus up to date without cancellation or delay as an incentive for staff to be more productive and to improve their skills.

- Assigning the IT Division with carrying out an online course for Academy staff on office automation programs.
- · Assigning the finance and administrative affairs department to develop a staff leave plan for Academy personnel in light of the corona pandemic
