## OIC Secretary General Elect visits IIFA Headquarters in Jeddah

H.E. ## Secretary General of the Islamic Conference for Awqaf visits IIFA in Jeddah



The Secretary General of the International Islamic Fiqh Academy (IIFA), His Excellency Professor Koutoub Moustapha Sano, received on Tuesday 08 Muharram 1443 corresponding to 17 August 2021, the Secretary General of the Islamic Conference for Awqaf, Eng. Mahmoud bin Ahmed Al-Awadi, at the headquarters of the Academy in Jeddah. His Excellency commended the efforts of the Secretariat General of the Conference in promoting community awareness of the

Awqaf developmental and community-based models. He then discussed with his guest a number of challenges facing the Awqaf sector in Muslim countries, and the mutual responsibility to promote and highlight the developmental and societal contributions of Awqaf.

His Excellency also discussed with his guest the mechanism for implementing one of the recommendations of the third session of the Islamic Conference for Awqaf, which called on the Figh academies and the relevant institutions to ascertain the general principles that should govern the relationship between the judicial authority and the executive authority with regard to the guardianship over Awqaf, and to study ways and means of improving the appropriate judicial foundations in Muslim countries to take advantage of them in addressing Awqaf issues during pandemics, as well as to develop and advance the mechanisms for establishing Waqf Monetary funds.

The two sides also discussed a number of

innovative development initiatives submitted by the Conference's Secretariat General to support the development and preservation of Awqaf proceeds at Muslim countries, with the aim of informing the Academy of the latter in order to review and study their Shariah legislation.

At the end of the meeting, the Secretary General of the Islamic Conference for Awqaf wrote a note in the guest book, and H.E. Secretary General of the Academy presented him with a copy of the fourth edition of the resolutions and recommendations of the Academy.

Then His Excellency opened the floor to the attendees to give their opinions and suggestions regarding work within the Academy. The meeting resulted in a number of decisions, notably:

- Reprinting "Zayed's Encyclopedia for the Rules of Jurisprudence" in a revised and concise edition.

- Uploading the CVs of the members and experts of the Council of the Academy on its website.

#### 19th Periodic Meeting of Divisions Heads

H.E. Prof. Koutoub Moustapha Sano, Secretary General of the International Islamic Fiqh Academy (IIFA), chaired on Thursday 03 Muharam 1443 corresponding to 12 August 2021, the nineteenth periodic meeting of the Academy divisions heads.

His Excellency started the meeting by welcoming the participants, congratulating them on the new Hijri year, praying Allah to make it a year of wellness and blessing for the Muslim Ummah and humanity at large. His Excellency then discussed the Academy's strategic plan, wherein he stressed the need to ensure the implementation of all its provisions, in coordination and cooperation with the rest of the department's staff, and urged participants to take the initiative in expressing the necessary proposals and opinions in order to achieve the desired objectives of the plan.

Then, His Excellency spoke about the need to give conferences and scientific symposia of the Academy the attention they deserve, as they are no less important than the Annual Session, so he instructed the Conferences Department to implement the activities and programs included in the strategic plan so that the activities of the Academy are evenly distributed throughout the year.

He also pointed out to the importance of



organizing seminars in partnership with the relevant authorities within Member states for the benefit of all and so that the Academy achieves the desired exposure.

The meeting discussed a number of topics and reached several decisions, notably:

- Preparing specialized scientific symposia and distributing them evenly throughout the year and organize some of them in partnership with relevant institutions within Member states, such as the Global Center for Combating Extremist Ideology (Etidal).
- The importance of early preparation for the annual sessions of the Academy for the next four years, beginning with the identification of the host countries and an early call for papers to facilitate the implementation of the Academy's objectives and its five-year strategic plan.

# 20th Periodic Meeting of Divisions Heads

H.E. Prof. Koutoub Moustapha Sano, Secretary General of the International Islamic Figh Academy (IIFA), chaired on Thursday, 17 Muharram 1443H corresponding to 26 August, 2021, the twentieth periodic meeting of divisions heads of the Academy. His Excellency welcomed the attendees and stressed the need to ensure the implementation of all items of the strategic plan to make certain the success of the Academy in achieving Member states' objectives and the aspirations. He also urged everyone to participate in constructive proposals and creative ideas in order to contribute to enriching the Academy's outputs of various programs and activities.

His Excellency also added that it is necessary

to prepare in advance for the next four Annual Sessions by confirming the names of the hosting countries and early call for papers of the topics that will be discussed during them. Then His Excellency noted the importance of documenting all the periodic meetings in written minutes and publishing them successively on the official website of the Academy and in the monthly bulletin, in order to ensure continuity and effective follow-up and completion of activities and programs. The meeting discussed several issues and topics, and reached a number of decisions, notably:

• Expedite the sending of the Academy's publications to Member states's universities. Issuing a quarterly magazine for the Academy,

the first issue of which will be published during September, provided that it is issued twice a year only.

• Assigning the Planning Department to draft the biographies of the deceased members of the Academy in the form of articles in preparation for publishing them in the next issue of the Academy's monthly bulletin.

Rare are those whom Allah guides to reformation, reconstruction, enlightenment and renewal..


Few are those who stand firm on principles and defend values. Their steadfastness is not shaken by calamities, their faith is not compromised by setbacks, and their sincerity is not affected by setbacks. The crises increase their faith and conviction that a bright dawn for the Ummah is undoubtedly coming, and that a bright future for its youth will undoubtedly come. And the years of wandering are inevitably fleeing. Calamities, setbacks and crises are but harbingers that precede victory, hasten the breakthrough, and rectify the course,

Indeed, Abu Ayman, you deserve to be one of those few for whom Allah will make a tongue of truth in the worlds, because you lived loyally and honestly for the Ummah, you dedicated your whole life to serving the Ummah's happiness, and you gave up the ornaments of life for the sake of the Ummah, and you sacrificed your health for its welfare.

You were, and you are still, one of those few who their legacy will never die, death can never be able to erase in any way your virtues and contributions as far as it will remain lofty in the lands of the Malay Archipelago, that ancient scientific edifice that you have rebuilt, and transformed with your determination and thoughtfulness from a submerged scientific institution to an international scientific institution. It became famous and keeps pace with the well-deserved competition and the power of the world's oldest institutions.

Indeed, by Allah, you transformed it from a traditional institution with few colleges and humble ambitions to a modern, witnessing and ambitious institution that in a short time has been able to produce and still produces thousands of bright, talented, active and capable youth.

Yes, You succeeded in correcting the negative stereotype about scientific institutions labeled as Islamic, thus you created an outstanding Islamic institution combining authenticity and modernity, creativity and innovation, and productivity and inventiveness. Its personnel have won and are still receiving dozens of medals and prizes for innovation and invention.



The last of which was the King Faisal Prize for the Service to Islam. Rather, you did not want the contemporary Islamic scientific institution to be less beautiful and elegant than the leading international scientific institutions. You built it with the unprecedented support of Malaysian leadership, one of the most beautiful campuses in the world. That beautiful masterpiece located in a quiet valley where the beauty of nature is integrated with the beauty of the surrounding mountains, and the purity of water is harmonious around. Rivers with clear sky at sunrise and sunset.

Yes...you were, and it is true that you should be one of those rare people who believed that lasting change is not achieved through violence and force, but rather through love and mercy.. and that the desired reform should be based on sound thinking, accurate awareness and a solid understanding of reality, and it is based on positivity, partnership, cooperation and interaction with the internal and external environment.

Yes.. O Abu Ayman, you were and deserve to be one of those few eminent people who deeply and powerfully diagnosed the causes of the Ummah's setbacks and crises, and the fact that it has been the best Ummah produced to witness over nations, to build the universe, and to make mankind happy at all times and places.

Yes.. you have provided an accurate description of what has become of this Ummah, which was once a leading and pioneering Ummah, then it became a withdrawn, dependent and a consuming Ummah after it had been a productive Ummah, and it became a submissive Ummah after it had been a strong Ummah, and it became an absentee Ummah after it has been an omnipresent Ummah. An Ummah which has become weeping over the past after having been an Ummah in control of its present and future. Yes, you were, O Abu Ayman, and history is the best witness, one of those blessed elite of the Ummah's sincere thinkers who pointed out to the horizons and proclaimed in forums that the Ummah is not lacking resources, thus Allah has blessed it with enormous natural and human resources, and it is not lacking in means thus it has all the means and abilities. And since this is the case and it is so, the disease of the whole

disease lies in the seizure of that sick withdrawalist thought, which suddenly created a sharp conflict between revelation and reason, and the case is that they complement each other and do not contradict, and create a bitter schizophrenia between the world and the hereafter, and the case is that they overlap and do not scatter, and suppose an alleged conflict between science and religion, and the case is that they befriend and do not clash.. Therefore, you called and you were very right, forty years ago, that all reforms should inevitably start from the reform of thought by rebuilding it in a sound ground that believes in complementarity between dualities, and refuses to contradict them. Rather, you have rejected all forms of violence, whether psychological or physical, and you have believed that true reform is that reform that stems from inculcating the values of love, mercy, kindness, honesty and altruism, courage, perseverance, and sincerity in the child's psyche, so that these values become an integral part of his personality, and a reference to him in his interactions with his environment. Yes..Abu Ayman..You translated this conception into a concrete reality.. when you established the first integrated international Islamic school from kindergarten to high school, concerned with implementing that vision and message.. Nearly thirty years have passed since I first met

you... you were for me and for many children of the Ummah a mentor and an example in productivity, hardwork, perseverance and optimism.. I swear to Allah.. you were and will remain a model of honesty, sincerity, chastity and altruism..

Yes.. you spent ten years and did not receive a cent of your salary. You refused to take a cent from the budget allocated to the university rector's office..

If I were to forget anything, I will never forget that difficult day at Kuala Lumpur Airport on December 29, 1998 when you were about to return to the Kingdom of Saudi Arabia, the Director of Financial Affairs, Brother Zailan, asked you, saying: What do we do with your frozen salaries with the Financial Division, which has reached hundreds of thousands throughout the years of your work as the university rector? You replied, with your usual smile, and your well-known altruism filling your sides.. Make it the first donation to an Awqaf Fund that you will establish to care for international students who were stranded and shrunken, and are just around the corner to return to their countries due to the cessation of supplies and the aid that came to them from those who wandered the horizons in order to collect donations for them. This is Abu Ayman..

Yes..Abu Ayman, I could not control my tears that day when I saw you boarding the plane to return to the land of the Two Holy Mosques.. For ten years, you had no salary, no reward, no bonuses.. for ten years.. you used to drive a very modest car for ten years.. and your office space did not exceed a few meters..

For ten years.. you were the last to return to his home.. Until Umm Ayman, may Allah protect her, one day said to your beloved friend, Dato Seri Anwar Ibrahim: You are also married to the university, because you returned home every day very late at night..

For ten years, you have proved to the whole world that reform is entirely possible. And that the Ummah's future is bright and prosperous, and that change is coming.

For ten years.. you rebuilt a university with few hundred students, divided it into three faculties with limited programs. When you were leaving, you left behind you a university with more than twelve thousands students, twelve faculties with more than a hundred programs..

For ten years.. you provided opportunities to educate more than five thousand male and female students from all over the world.. The number of international students there before your arrival was less than a hundred male and female students.. Praise be to Allah, as those students who have had the honor to study in that institution have become leaders and pioneers in their countries and societies..

For ten years.. Allah granted you success to plant a blessed tree, whose root is solid in the earth and its branches are in the sky, Allah willing.. O my father.. and my teacher.. and the father of the thousands who made up, rather hundreds of thousands of whom you have favored... be assured that your memory will remain as long as there is an iota of life left in the soul.. and that your enlightened thought that you spreaded will remain alive and vibrant as long as the Ummah remains.. and that your reward will remain, Allah willing, as long as a bird eats from those trees that you planted in the village of Gombak in the suburb of Kuala Lumpur..

It is a covenant upon us and the children of the Ummah to pray for your mercy, forgiveness, and contentment of Allah, as long as we prostrate ourselves to Allah..and as long as we do fast..and this is the least you deserve..

O Mother.. Umm Ayman.. please accept my condolences and the condolences of my humble family to whom you were a mother and grandmother.. and please accept the condolences of thousands of university graduates and employees whom Abu Ayman extended love and care..

Indeed we know for sure that Abu Ayman would not have been able to make the achievements and successes' that he has achieved..if it were not for Allah's success and then your support, patience and companionship..

Please accept the condolences of all those who believed, worked and defended the reform of Islamic thought...

You, my dearest brothers and sisters, children of Abu Ayman, accept our heartfelt condolences, and the condolences of the Ummah in this affliction.. And always and forever remember the grace and benevolence of Allah upon you that He made you from the offspring of Abu Ayman and Umm Ayman..

This prestigious scientific institution has also become the most representative of Ijtihad in general and collective Ijtihad in particular, as it adopts the approach of dialogue, the principle of consultation, and the consensus mechanism in issuing its resolutions and recommendations.

It has indeed become the first shariah reference that the countries of the Muslim world and Muslim societies resort to in ordertoclarifytheShariahrulingsregarding issues of concern to Muslims, to solve calamities, to cope with developments, and to rationalize practices.

None of this would have been possible

without the blessed efforts of the great late scholars who believed in this cause and dedicated much of their lives in the service of knowledge and Islamic Fiqh, may Allah have mercy on them all.

Therefore, in appreciation to the wonderful efforts and distinguished contributions of these eminent deceased scholars of the Academy, and in recognition of their appreciated services in the development of the Academy, and in our desire to preserve their memory, and to express our sincere loyalty to them, the Secretariat General of the International Islamic Figh Academy decided to allocate a space in its monthly newsletter to introduce them to the younger generations. We pray to Allah, the Almighty, to bless the lives of the living scholars of the Academy who continue to strive for the Muslim Ummah.

Finally, we hope that this initiative will be the basis of a comprehensive encyclopedia on the Academy's scholars and experts that the Secretariat General plans to publish in the near future, in sha Allah.

He was also member of the Saudi Judicial Council, then a judge in the Great Court of Madinah, a teacher at the Prophet's Mosque, a member of the Islamic Figh Academy, of

the Muslim World League, a teacher at the Higher Institute of the Judiciary, a teacher in postgraduate studies at the College of Shariah in Riyadh, and Secretary of the Public Library of the Islamic University of Madinah.

H.E. 
## His Excellency Sheikh Dr. Mohamed Habib Ibn khoja

His Mahdara gained in the past twenty years international fame in addition to its local fame, as students
