IIFA Secretary General participates in a Symposium on Peace in Abu Dhabi

At the invitation of Al-Ittihad Newspaper and the TRENDS Research & Advisory center in Abu Dhabi, H.E. Prof. Koutoub Moustapha Sano, Secretary General of the International Islamic Fiqh 1443, corresponding to 21 September 2021, in a symposium in Abu Dhabi, United Arab Emirates, entitled "Promoting the Culture of Peace and Tolerance in the World: What Do we Need to do?" The symposium was organized to celebrate the International Day of Peace and was opened by H.H. Sheikh Nahyan bin Mubarak Al Nahyan, Minister of Tolerance and Coexistence in the UAE. H.E. Prof. Sano's speech focused on the "culture of tolerance and peace as a starting point to end conflicts globally and regionally." H.E. stressed that the Quranic verse, "And of His signs is the creation of the heavens and the earth and the diversity of your languages and your colors. Indeed, in that are signs for those of knowledge (Ar Rum: 22), is a declaration and confirmation that difference is a universal order, that is, the difference of tongues and colors refer to the difference in cultures, languages, races, tastes and beliefs, which is in reality a matter of diversity and richness not a difference of contradiction and conflict. The purpose of this difference is to be the starting point for integration, cooperation, synergy, and solidarity. H.E. added that the «conflicts that we are witnessing today in the world are only the result of the departure from the difference of diversity and richness to the difference of containing contradictions and conflicts, which is due to the beliefs and behaviors the individual learns that from environment and society that pushes him to act contrary to divine



laws in the universe. God did not create human beings to fight under any pretext or justification, but rather to benefit from difference and diversity positively and to consolidate the values of tolerance, peace and the culture of moderation that must play its role in confronting these conflicts and ending the culture of violence and elimination". As for the relationship between peace and tolerance, H.E. said, "It is fascinating to note how the Prophet of Islam (PBUH) connected between human fraternity and spreading peace in the sahih hadith: "You will not enter Paradise until you have faith and you will not have faith until you love each other. Shall I show you something that, if you did, you would love each other? Spread peace between yourselves." True brotherhood is based on tolerance, and the meaning of tolerance is peace, as if tolerance is a prelude to peace. Therefore, there is an urgent need to promote tolerance and spread peace and compassion among people so that they all live in safety and tranquillity, not being afraid of anything because of religious, sectarian or ethnic differences."

In his speech, H.E. praised the qualitative shift in the culture of tolerance and peace from the intellectual and theoretical world to the practical world at the UAE, through its uniqueness in the world by establishing an independent ministry called the Ministry of Tolerance and Peaceful Coexistence, to disseminate and consolidate the values of tolerance and coexistence, and to promote awareness over their importance and role in achieving security, safety and stability. H.E. also praised the importance of this symposium, which he considered an opportunity for tolerance and peace to become a permanent behavior and part of our daily life, cutting away the repeated rhetoric about them and making them our acquired values practiced all of the time. H.E. then concluded his speech by commending the outstanding work done by TRENDS center and Al Ittihad Newspaper for organizing such interesting seminars and their willingness to support efforts to establish peace and compassion among peoples and religions. It is worth mentioning that some clergymen representing Judaism, Christianity and Hinduism participated in the symposium. The Secretary General of the Muslim Council of Elders, Dr. Sultan Al-Rumaithi, participated via videoconferencing.

IIFA and Bank Indonesia hold a meeting on Islamic Social Finance

On Tuesday 21 Safar 1443H, corresponding to 28 September 2021, the International Islamic Figh Academy (IIFA), with the participation of H.E. Prof. Koutoub Moustapha Sano, the Secretary General, held the second preparatory meeting with the delegation of the Central Bank of Indonesia to discuss the program of the Economic Figh Symposium on Islamic Social Finance to be held during the Eighth Sharia Week Festival in Indonesia in October. On the Indonesian side, representatives of the Central Bank of Indonesia, the Ministry of Religious Affairs, the Ministry of Foreign Affairs, and the National Sharia Council participated in the meeting. Ms. Rolina, the representative of Bank Indonesia, opened the meeting by expressing her thanks to His Excellency the Secretary General of the Academy, for participating in this meeting. She added that the Indonesian government, mainly represented by the Ministry of Religious Affairs, was very happy and honored with the participation of the Academy in this important event. Ms. Rolina also pointed out that the Sharia Week Festival represents one of the most important events in Indonesia, in which many different activities and programs are held and discussed in light of Sharia provisions, especially in relation to banking and financial institutions. The festival has become one of the most prestigious programs globally since its recognition as part of the World Economic Forum. Annually, national and international organizations, institutions, and associations participate in this festival to discuss integrating Islamic economy and finance into national and international policy agendas. Therefore, the organizers of the festival decided to hold a series of specialized scientific symposia and forums on many vital



topics of benefit to the financial sector through virtual communication media; thus shows the paramount im portance of holding the symposium mentioned above on Islamic social finance in partnership and cooperation with IIFA, in the hope of raising awareness of the status and importance of this financing and its significant role in combating poverty and deprivation in societies. On his part, the Secretary General of the Academy greeted the Indonesian delegation, expressing his eagerness and aspiration to participate in this event. He also stressed the Academy's role in the Member states by supporting these scientific endeavours that benefit Muslim countries and Muslim communities worldwide. His Excellency also mentioned that he personally hopes that the Republic of Indonesia will become a recognized global center for Islamic social financing, and the advancement of its causes and institutions by introducing this financing and how to benefit from its effective tools to combat poverty. His Excellency confirmed that he had already expressed this wish to Indonesian officials during his recent visit to Indonesia. The Indonesian delegation briefed His Excellency and his staff on the detailed presentation prepared by

the Joint Working Committee organizing the symposium, including the most important contents of the program and the tasks of each of the parties involved in the preparations. This presentation was well received, and His Excellency approved all the points contained in the draft program. He consequently assured his counterpart that the Academy is ready, with all its departments, to provide the support and scientific requirements, especially with regard to appointing speakers in the symposium and inviting a significant number of the Academy's members and experts to participate in the symposium, as well as His Excellency's personal approval to deliver the opening address at the event. In the hope of better coordination and communication between the Academy and the Indonesian parties involved in ensuring the symposium's success, His Excellency appointed Mrs. Sarah Amjad, Director of Family and Women's Affairs Department as a representative of the Academy to communicate with the Indonesian side. Secretary General participates in the UN Seminar on the Role of Islamic Social Finance and Climate Action

On Tuesday 21 Safar 1443 corresponding to 28 September 2021, H.E. Prof. Koutoub Moustapha Sano, Secretary General of the International Islamic Figh Academy (IIFA), participated in the United Nations Global seminar on the Role of Islamic Social Financing in Achieving Sustainable Development UN Goal No. 13 concerning climate change, and the social, economic, and environmental issues that it poses to humanity. The seminar explores ways to use this funding to provide the necessary support and relief to alleviate poverty and minimize the effects of natural disasters on people and societies. This seminar is part of an important initiative launched by the United Nations last May, in partnership with the Islamic Development Bank Group (IsDB), to initiate dialogue in order to support efforts to recover from the Corona pandemic and its dire economic and social effects, especially on the least developed countries and poor communities. The initiative aims to achieve the necessary resilience to strengthen the economies of the most fragile countries by introducing new development models characterized by an inclusive and resilient base nature. In his speech, the Secretary General of the Academy expressed his thanks to those in charge of this excellent initiative, which deals with a subject that Islamic Sharia has always paid special attention, that of providing adequate support to the needy and those affected by natural disasters and economic and social crises. His Excellency



explained that Sharia, in its entirety, has ad dressed the issue of preserving the environment by prohibiting and preventing its abuse and destruction. Human life on our planet is an integral part of the environment and that the whole planet is composed of humans, animals, and plants on an equal footing. His Excellency added that the conservation of the environment and climate has become a shared moral obligation today, which motivates us to implement and apply the teachings, values and principles of Sharia that enable us to preserve and maintain our environment safe and sound, for our own and the world's safety against the consequences of environmental violations and aggressions. As far as Islamic social financing institutions are concerned, they should be used to achieve these objectives and to reach the minimum level of prosperity and social solidarity. His Excellency explained that Islamic sociál financing hás multiple institutions, on top of which are three basic

financial institutions that can serve these objectives and provide appropriate solutions to such problems. These institutions are the Zakat Institution, the Waqf Institution, and the Wills Institution. Each of these three institutions could solve so many problems by utilizing their ability and capabilities to spend on projects and programs aimed at preserving the environment and providing relief to those affected by natural disasters and the resulting crises. His Excellency also clarified the importance of strengthening cooperation be-tween the Academy and the institutions active in the field of environmental conservation and mitigation of the destructive effects of climate change resulting from the random violation on the environment, considering that everyone is targeted with all the consequences of harming the environment, which requires strengthening solidarity and cooperation institutions to protect the environment and help those affected by disasters and crises. It is worth mentioning that the Academy had already adopted a resolution that approved the Shariah legitimacy of providing support from Zakat funds to the afflicted in areas of disasters, earthquakes, floods, and famines. Several eminent personalities in this field participated in the seminar, such as H.E. Dr. Ahmed Al Meraikhi, Special Advisor to the UN Secretary General, and H.E. Prof. Mehmet Asutay, Director, Durham Center for Islamic Economics and Finance.

Secretary General participates in the Global Islamic Finance Scholars Conference

H.E. Prof. Koutoub Moustapha Sano, Secretary General of the International Islamic Fiqh Academy (IIFA), participated on Wednesday, 29 Safar 1443 (06 October 2021) via videoconference in the Sixteenth Global Conference of Shariah Scholars in Islamic Finance, held this year under the title «Islamic Finance and the Fiqh of Crises», organized by the International Shariah Research Academy for Islamic Finance, known as ISRA. His Excellency delivered the opening speech of the ceremony on «The Foundations of Applying Fiqh in Dealing with the Crises of Contemporary Financial Transactions». His Excellency opened his speech by thanking and congratulating ISRA, the event organizer, and stating that this event has become a global benchmark for research and scientific studies in the field of Islamic finance and a guide for its professionals and those interested in it. His Excellency added that ISRA's blessed efforts have contributed over the years to consolidate the role of Islamic finance in the global economy and highlight its deserved position as one of the economic solutions needed to address the financial crises our world is witnessing today. Then His Excellency explained that «one of the duties of the scholars is to enlighten the path of those who seek knowledge, and one of the holiest duties is to teach the public the rules of their religion and to inform them of their duties and prohibitions. These are the legal rules transmitted in the folds of the texts of the Quran and Sunnah through the foundation of the universal principles of the Shariah, the major legal maxims, as well as the supreme objectives of the Sunnah in order to facilitate people in complying with the divine commands,



avoiding the divine prohibitions, and confirming the validity of Shariah for every time and place, and for every human being at all times. Then His Excellency explained that «one of the duties of the scholars is to enlighten the path of those who seek knowledge, and one of the holiest duties is to teach the public the rules of their religion and to inform them of their duties and prohibitions. These are the legal rules transmitted in the folds of the texts of the Quran and Sunnah through the foundation of the universal principles of the Shariah, the major legal maxims, as well as the supreme objectives of the Sunnah in order to facilitate people in complying with the divine commands, avoiding the divine prohibitions, and confirming the validity of Shariah for every time and place, and for every human being at all times. His Excellency also added that «if crises, with their emergencies, pandemics and disasters, are part of the eternal divine laws that will never cease to befall nations, and there will never be a time without them throughout the ages, then dealing with them wisely and firmly requires a full grasp of the universal faculties of the Sharia, the objectives of the Shariah, and a sound understanding of the consequences, for the nature of crises, be they emergencies, pandemics or disasters, cannot be covered

by derivatives, and the fatwas of the past are not able to cope with them, given their components, effects and consequences.» His Excellency said that there are essential bases that can be considered in building blocks for developing new fiqh, which he called the figh of crises. The bases of this figh can be summarized in the following premises: • First: upholding generalities mentioned in the texts related to pandemics and emergencies, such as the hadith of the Prophet (PBUH): «Whoever sells a fruit and it is affected by a pandemic does not take any of it, why would any of you take his brother's money?» •Second: Use of magasid «Shariah purposes» on transactions, including the purpose of justice. •Third: Compilation of the rules of jurisprudence, in particular, the rule « No harm to either party « and the rules derived therefrom. • Fourth: Considering the consequences of actions. His Excellency concluded his speech by thanking the organizers for allowing him to address the conference participants through this distinguished platform on a topic of great importance and complexity, hoping that Muslims and all humanity will benefit from this renewed thought and original Ijtihad, and that it will have a positive impact on the development and advancement of the Islamic finance sector, and finally wishing the conference success.



Secretary General holds a meeting with Special Advisor to UN Secretary General



H.E. Prof. Koutoub Moustapha Sano, Secretary General of the International Islamic Fiqh Academy (IIFA), held a consultative meeting with H.E. Dr. Ahmed Al Meraikhi, Special Advisor to the UN Secretary General, via videoconference on Tuesday 28 Safar 1443 (05 October 2021). During the meeting, the two sides exchanged views on the specialized seminar organized by the UN last week on the role of Islamic social finance in combating the effects of climate change. Secretary General participates in the UN Seminar on the role of Islamic Social Finance



On Wednesday, 29 Safar 1443 corresponding to 06 October 2021, H.E. Prof. Koutoub Moustapha Sano, Secretary General of the International Islamic Figh Academy (IIFA), participated in a seminar organized by the Office of the United Nations High Commissioner for Refugees on the role of Islamic social financing in achieving the United Nations Sustainable Development Goals, and also to discuss ways of using this financing to provide the necessary support and assistance to refugees and forcibly displaced people around the world. This seminar is part of the initiative taken by the United Nations earlier this year to call for dialogue to support efforts to recover from the Corona pandemic and its disastrous economic and social effects, particularly on developing countries. The initiative aims to provide a new funding methodology that can bring relief and support to war-affected people in all regions witnessing violent conflicts worldwide. H.E. Mr. Khalid Khalifa, Representative of the United Nations High Commissioner for Refugees to the Gulf Cooperation Council and Advisor to the High Commissioner for Islamic Finance, said that the UNHCR has

benefited during the recent period from the donations and assistance made by Muslims worldwide for the benefit of the Refugees Zakat Fund, thus realizing the legitimate fatwa issued by the Academy which has been well received and accepted by the donors all over the world. The fatwa issued by the Academy stipulates that it is permissible to spend Zakat money to help and rescue the refugees and the afflicted around the world. H.E. Mr. Khalid Khalifa confirmed that the Refugees Zakat Fund has witnessed a remarkable increase in the amount and number of donations it receives annually, which has helped more people in need. He attributed this to the joint awareness campaign conducted by UNHCR in partnership with the Academy during the last month of Ramadan. On his part, His Excellency, Secretary General of the Academy, explained the scientific and Sharia role of the Academy as the first international jurisprudential reference for Muslim countries and communities. This role consists of issuing fatwas, resolutions, and recommendations to encourage donors to provide the necessary support and assistance to refugees and forcibly displaced persons. He also stressed this issues human dimension, which transcends the boundaries of religion, color, race, and gender. His Excellency also added that the joint awareness campaign between the Academy and the UNHCR, to highlight the necessary human needs and displaced persons refugees the world, has contributed and contribute significantly continues to

to shedding light on this human tragedy from which humanity suffers, predominantly Muslim countries, which account for about half of the world's refugees. His Excellency explained that the Academy would continue to provide religious and intellectual support to UNHCR by urging Muslims to spend their Zakat and allocate Awqaf and charities to fund UNHCR>s activities and programs aimed at saving millions of people who are living in extremely difficult conditions under the burden of poverty, deprivation, and destitution. His Excellency stressed that all Islamic social funding mechanisms should be used, including Zakat, Awqaf, charities, vows, and penances, to ensure a decent and secure life for the affected and afflicted people by providing them with the basic elements of life such as food, clothing, and shelter. The seminar was also attended by H.E. Dr. Ahmed Al Meraikhi, Special Advisor to the UN Secretary General, and H.E. Sheikh Omar Subedar, Director of Operations at the Halal Control Authority, Canada.







11th Monthly Staff Meeting

H.E. Prof. Koutoub Moustapha Sano, Secretary General of the International Islamic Fiqh Academy (IIFA), presided over the eleventh monthly meeting of the Academy's communities on Sunday, 27 of Muharram 1443 (05 end of September 2021). He was the first representative member of the Republic of Indonesia to the Council of the International Islamic Fiqh Academy, IIFA until his death. His Eminence graduated from the Faculty of Islamic Law at the State Institute of Islamic Religion in Jakarta and obtained a master's degree in Islamic Studies from the Faculty of Dar Al Uloom, Cairo University, Republic of Egypt. His Eminence assumed various academic and administrative positions in his country



Indonesia and abroad, namely as a lecturer in Islamic history, philosophy and law, comparative studies in Islamic fiqh at the State Institute of Islamic Religion, Dean of the Islamic College at the Islamic University in Jakarta, Vice-President of the Central Council of "Tarjeeh Muhammadiyah" in Jakarta, and member of the Islamic Fiqh Committee of the National Law Development Council. His Eminence is the author of several books on Islamic laws (in Indonesian) related to marriage, inheritance, transactions, state, and government. In Arabic, he authored the Inheritance System in Indonesia between Urf and Shariah.

His Eminence Sheikh Abdul Aziz Muhammad Issa


Born in 1908 in El-Beheira Governorate in the Arab Republic of Egypt and passed away in Cairo in 1994. His Eminence was the first representative member of the Arab Republic of Egypt to the Council of the International Islamic Figh Academy, IIFA. May Allah have mercy on him. His Eminence memorized the Holy Quran from an early age and attended the circles of knowledge at Al-Azhar since the age of ten. He obtained the secondary certificate of Al-Azhar after five years instead of nine of regular studies in the general department thanks to his ingenuity and progeny and then enrolled at the of higher studies department of Al-Azhar where he obtained Alamiya (PhD), where he was the best student among his peers. He then continued his studies by focusing on rhetoric, literature, education, and psychology for three years, thus fulfilling the highest levels of scientific accreditations

of Al-Azhar University. At the end of his studies, he obtained what was then called a certificate of specialization, which entitled its holders to be called "Allamah" (scholar). His Eminence served various administrative and academic positions, as a lecturer at the Faculty of Sharia at Al-Azhar University, Director of Rissalat al-Islam (Message of Islam) Magazine, Assistant Supervisor of Islamic research and culture, inspector of Arabic and Islamic sciences in religious institutes, Grand Sheikh of the Institute of Islamic Missions, Director General of Inspection of Religious and Arabic Sciences, undersecretary of Al-Azhar Al-Sharif, appointed member of the Egyptian Shura Council, member of three specialized national councils: the National Education Council, Scientific Research & Technology, the National Services Council, and the National Council for Culture & Media. His Eminence is the author of a number of books, research articles, radio conversations, and fatwas that he presented on the radio for the span of 40 years. One of his most notable books is "How to Perform Umrah and Hajj". His Eminence was the recipient of the First Class Medal of the Order of the Republic and the First-Class Medal of Science and Arts on the occasion of Al-Azhar's millennium anniversary.



His Excellency Sheikh Mustafa Ahmed Al-Zarga

H.E. Sheikh Mustafa bin Ahmed bin Muhammad Al-Zarqa was born in 1904 in Aleppo, Syria, and passed away in 1999 in Riyadh, Saudi Arabia, may Allah have mercy on him. His Excellency was an appointed member of the Council of the International Islamic Fiqh Academy in recognition of his scholarly standing and intellectual contributions to the renewal of Islamic Figh. His Excellency graduated from both the faculties of law and literature and was thus the first in Syria to combine the three cultures of Shariah, law and literature. He then obtained a diploma in Islamic Shariah from the Faculty of Law at Fouad I University, now known as Cairo University. His Excellency assumed various academic and administrative positions inside and outside Syria, as Minister of Justice, then Minister of Awqaf, Professor of Hanafi jurisprudence and Arabic literature at Al-Khusrawiya Religious School and the Umayyad Mosque, Professor of civil and Shariah rights and civil law as well as he the



Head of the Civil and Legal Rights Department at Damascus University. His Excellency actively participated as an expert in the Kuwait Fiqh Encyclopedia and a member of the Expert Committee in the Arab League's Legal Department. His Excellency is also remembered for his active

role in the establishment and development of several Islamic universities in Damascus, Cairo, Madinah and Makkah, as well as for his reputation as a distinguished poet. His Excellency is the author of several books and research articles. Among his most important publications include A General Introduction to Figh, Introduction to the General Theory of Commitment in Islamic Fiqh, Sale Contracts in Islamic Fiqh, Explanation of Syrian Civil Law, Islamic Fiqh and its Schools, Istislah and Massalih Mursala (Problem-Solving and Largestricted Public Interests) in John Schools Unrestricted Public Interests) in Islamic Fiqh, Rulings on Waqf, Harmful Acts and their Guarantee, Istisna contract and its impact on Islamic Banking Activities, Insurance System and its Shariah Opinion, Intellect and Figh in Understanding Ahadith, the Greatness of Muhammad, The Seal of the Messengers and the Pinnacle of Human Splendors, Poetry Collection: Rainbow.

His Eminence Sheikh Muhammad Miko



Born in 1935 in Fez and passed away in 1996 in Rabat, Kingdom of Morocco, H.É. Sheikh Mohammad Miko was the first representative member of the Kingdom of Morocco to the Council of the International Islamic Fiqh Academy. May Allah have mercy on him. His Excellency graduated from at the University of Al-Qarawiyyin in Fez, then held various administrative and academic positions inside and outside the Kingdom of Morocco, including as a team leader in the Supreme Council of the Court of Cassation, Director of Civil Affairs Department at the Ministry of Justice, member of the Royal Commission for Judicial Reform, Chairman of the Royal Commission for Codification, member of Negotiation Team on judicial cooperation with some European countries, especially The Hague Organization for Private International Law, Attorney General at the Court of Appeal of Tangier, President of the Regional Court of Marrakech, President of the Regional Court of Rabat, Director of the Department of Civil Affairs at

the Ministry of Justice, Secretary General of the Council of Arab Ministers of Justice, President of the Chamber of the Supreme Court, Secretary General of the Advisory Council for Human Rights. His Excellency also worked as a professor of civil law, payment law and judicial organization in the following Moroccan institutions: the National Institute of Judicial Studies, the National School of Public Administration, Executive Training School in Quneitra of the Ministry of the Interior, representative of the Kingdom in the General Authority for the Unification of Arab Civil Laws, member of the Expert Committee for the Unification of Arab Civil Law, Chairman of the Expert Committee for drafting a unified Arab law on civic status, member of the Judicial Authority of the Arab Maghreb Union. His Eminence is the author of several books and research articles in Figh and law, including Regulations for Social Affairs, Arab Women and the Family Code, in addition to his lectures on private judicial law, and the Rules of Procedures for Social Affairs.

His Eminence Sheikh Abdullah Al-Bassam

H.E. Sheikh Abdullah Al-Bassam was born in Unaizah, Kingdom of Saudi Arabia, in 1346, and passed away in the year 1423. May Allah have mercy on him. His Eminence was an appointed member of the Council of the International Islamic Figh Academy, who participated in the establishment of the Academy, and is credited with naming the Academy the International Islamic Figh Academy instead of the International Figh Council to distinguish it from the Figh Council of the Muslim World League. His Eminence was a hafiz (memorizer) of the Holy Qur'an, and he learned from his father the principles of Fiqh, grammar, tafsir, seerah, and Islamic history. He was also taught by the great scholar Abdulrahman bin Nasir al-Saadi for many years - may Allah have mercy on them - and then joined the Shariah

College in Makkah Al-Mukarramah. His Eminence took over the judiciary in urgent partial cases in Makkah Al-Mukarramah, while teaching at Al-Masjid Al-Haram. He also presided over the Grand Court in Taif and the Court of Cassation in Makkah Al-Mukarramah. His Eminence is the author of several publications and books, notably: Explanation of Umdat al-Ahkam, A Summary on Umdat al-Ahkam, Scholars of Najd for Eight Centuries, The Clear Verdict on the Zakat of Jewelry, Anthology of Divergence Issue, Clarification the Rulings related to Bulugh al-Maram, Debunking Al-Athaar al Muhamadiya and Exposing its Harmful Effects, Commentary on Umdat al-Fiqh, Refining Umdat al-Ragheb, Explanation on Uncovering Suspicions.



His Excellency Dr. Abdelhadi Boutaleb



Born in 1923 in Fez and passed away in 2009 in Rabat, Kingdom of Morocco, H.E. Dr. Abdelhadi Boutaleb was an appointed member of the Council of the International Islamic Fiqh Academy. May Allah have mercy on him. His Excellency graduated from the University of Al-Qarawiyyin, with a BA and a PhD in Sharia, in addition to a PhD in law. His Excellency then served various administrative and academic positions as professor at Al-Moulawiya School, professor of law at the universities of Mohammed V in Rabat and Hassan II in Casablanca, professor for HM King Hassan II, and his son, HM King Mohammed VI. He was appointed Minister of Labor and Social Affairs upon establishing the first Moroccan national government after independence, Secretary of State for Information, Youth and Sports, Min

ister of Justice, Education, and Foreign Affairs, Morocco's ambassador to Lebanon, Syria, USA, and Mexico. He also served as President of the Moroccan Parliament and Advisor to HM King Hassan II.His Excellency is the author of numerous works on political science, law and literature, in both Arabic and French, amounting to 58 publications, the most important of which include Family Rights and Women's Liberation, At the Crossroads of Arab Nationalism and Islamic Solidarity, Insights on the Arab Cause (in Arabic and French), between Arab Nationalism and the Islamic League, a Glossary for Correcting Arab Media Language, The Muslim World and The New World Order (in Arabic and French), Towards Another Fairer and More Human Globalization.

His Eminence Sheikh Justice Muhammad Ali Abdullah

H.E. Sheikh Justice Muhammad Ali Abdullah was born in 1949 in the city of Lomé in the Republic of Togo, and passed away in 2010 in Niamey, Niger, may Allah have mercy on him. His Eminence was the first representative member of the Republic of Niger to the Council of the International Islamic Fiqh Academy, IIFA. His Eminence obtained a BA in Law from the Republic of Tunisia, and a diploma from the National School of Magistrates in France. His Excellency assumed various academic and administrative positions inside and outside his country, Niger, as a judge in the First Investigation Office in the Court of First Instance in the capital, Niamey, and as Head of the Agadez City Court Department.



His Excellency Sheikh Dr. Abdulaziz Al-Khayat



May Allah have mercy on him His Eminence belongs to a family renowned for its knowledge in Tunisia. He received his primary education at Al-Sadiqiah School and the Charitable School, then continued his studies at Al-Zaytuna Mosque until obtaining Alamiya (PhD). His Eminence assumed various academic and administrative positions. He worked in the education sector for forty years and was an appointed expert at the Árab League for laws codification, member of the Supreme Islam



ic Council of Tunisia, member of the Tunisian Parliament. Sheikh Djait was also the Grand Mufti of Tunisia for ten years. He was considered one of Al-Zaituna's most prominent scholars in Usul Al-Fiqh (Fundamentals of Fiqh). Mali, supervisor of the Arabic teachers training program in Mali (Timbuktu Center), Professor of French and African Literature at Muhammad Assica Institute in the capital Bamako, and the Educational Director at the Institute of Public Education in the capital, Bamako, media supervisor of preaching and counselling activities, technical advisor on Islamic Affairs at the Ministry of Information, advisor to the Presidency of the State in charge of Islamic and Arab Affairs, and General President of the Islamic Productive Foundation, in addition to his Dawah efforts in spreading Islam in the African continent. His Excellency is the author of several books and research articles, notably a translation and an exegesis of the meanings of the Noble Qur'an into the French language, an Introduction to the Noble Qur'an, as well as a Translation an Exegesis of the Psalms in French.
