### Minister of Islamic Affairs of the Kingdom welcomes the Secretary General of the Academy at the Ministry's headquarters in Jeddah

H.E. Prof. Koutoub Moustapha SANO, Secretary General of the Academy, accompanied by a delegation from the Academy, paid a courtesy call on H.E. Sheikh Dr. Abdulatif bin Abdulaziz Al-Sheikh, Minister of Islamic Affairs, Call and Guidance of the Kingdom of Saudi Arabia at the headquarters of the Ministry in Jeddah on Monday 19 Shawal 1442 corresponding to 31 May 2021.

His Excellency the Minister welcomed the H.E. the Secretary General and the accompanying delegation and congratulated him on his appointment as Secretary General of the Academy, noting the great role entrusted to the International Islamic Figh Academy in our times as a legal reference for nearly two billion Muslims. His Excellency the Minister spoke about the need to pay more attention to correcting misconceptions about Islam, and to avoid the use of religion for worldly gains and political ambitions, mentioning in this regard the importance of adhering to moderation and temperance in order to combat deviant thoughts, and aberrant fatwas issued by people far from the essence of Islam. His Excellency the Minister also stressed the need for the members and experts of the Academy, who represent fifty-seven (57) countries, to fulfill their legitimate responsibility in explaining the divine law and guiding people to the correct belief and acts of goodness. He also expressed the importance of joining efforts and coordinating approaches to promote a culture of moderation and temperance. He concluded his speech by saying to the Secretary General of the Academy: "I have confidence in the knowledge of Your Excellency, and I know that you are intelligent, skillful, energetic and experienced, and therefore, we hope that you will advance the Academy to enable it to achieve its mission and objectives", stressing in this regard the readiness of the Ministry to provide full support to the Academy within the framework of what the law allows, and expressing at the same time his agreement to sign a memorandum of understanding between the two parties after consultation with the competent authorities.

For his part, H.E. Prof. Koutoub Moustapha Sano, Secretary General of the Academy, expressed his sincere thanks to His Excellency the Minister for his warm welcome. He also conveyed to His Excellency the Minister the greetings of H.E. Sheikh Saleh bin Abdullah bin Humaid, President of the Academy, praising the appreciated efforts made by His Excellency the Minister to develop the activities of the Ministry and its performance in order to meet the challenges of the time. H.E. Prof. Koutoub SANO then presented an overview of the Academy, its history, vision, mission, objectives, means as well as its members, noting in this respect that the Academy is a global, intellectual and scientific body emanating from the Organization of Islamic Cooperation. It is considered as a scientific platform for intellectual convergence and integration of knowledge among the jurists and intellectuals of the Ummah rep-



resenting fifty-seven (57) Member States. On this occasion, His Excellency praised the generous care that the Academy has received -since its establishment to datefrom the wise leadership of the Headquarters State and the Saudi people with all its components.

His Excellency also reviewed some of the achievements of the Academy, represented in its resolutions and recommendations, which amount to two hundred and thirty-eight (238) resolutions and recommendations on various topics and issues of concern to Muslims worldwide, as well as a good set of multiple statements issued from time to time, the most recent of which is the statement of the Secretariat General of the Academy regarding the Shariah rulings on the taking of available vaccines against Covid-19, the use of Zakat funds for the purchase of vaccines, and the precautionary measures taken by the Saudi government regarding visitors to the two holy mosques during Ramadan.

His Excellency affirmed that the Academy has continued to provide Shariah assistance to ifta bodies, Shariah councils and Islamic financial institutions in OIC member states and Muslim communities, regarding Shariah provisions governing calamities and developments.

On this occasion, His Excellency expressed his aspiration to strengthen cooperation, partnership and coordination with the Ministry in various fields of common



interest, especially in the field of joint organization of conferences, seminars and roundtables, as well as in the preparation of researches and studies, exchange of publications, in addition to coordinating efforts and unifying visions to disseminate the approach of moderation and temperance in the world. His Excellency also emphasized that the mission of the Academy is to present the teachings of Islam in a moderate manner by emphasizing their advantages, greatness, flexibility, applicability at any time and place, as well as their full capacity to provide practical solutions and satisfactory answers to the problems, challenges and calamities of contemporary life, based on the Qur'an and Sunnah of the Prophet (PBUH), as well as on the rich Islamic

At the end of the meeting, H.E. Prof. Koutoub SANO invited His Excellency the Minister to visit the General Secretariat of the Academy, and then he answered the journalists' questions on the importance of spreading a culture of moderation and the right balance. He also emphasized in his answer that the achievement of security and stability and the realization of happiness and prosperity lie in the commitment of the Ummah, peoples and individuals, to the culture of the middle way and the approach of moderation, pointing out meanwhile what Allah the Almighty said:

"And We have made you an intermediary nation so that you may be a witness for mankind and the Messenger may be a witness against you." alBaqarah:143

This verse calls upon Muslims to be moderate if they wish to become witness and guide for other nations

At the end of the visit, both parties exchanged souvenirs. His Excellency the Minister presented to the Secretary General of the Academy a luxurious and elegant copy of the Holy Qur'an of Madinah while the Secretary General of the Academy presented him with a copy of the fourth edition of the Academy's resolutions and recommendations and the first issue of its scientific series.

Within the framework of his relentless endeavor to strengthen cooperation and partnership relations between the International Islamic Figh Academy and the religious and scientific institutions and centers in the member states of the Organization of Islamic Cooperation (OIC) and the countries of Muslim communities outside the Muslim world, His Excellency Prof. Koutoub Moustapha Sano, Secretary General of the International Islamic Figh Academy met with His Excellency Dr. Dato Zulkifli Mohamad Al-Bakri, Malaysian Minister of Religious Affairs, in his office in the city of Putrajaya, Malaysia.

His Excellency the Minister welcomed the Academy's Secretary General, congratulated him on assuming his duties as Secretary General of the Academy, and also congratulated him on the developments and the qualitative changes that have occurred in the General Secretariat of the Academy since he took over a few

His Excellency also expressed his great happiness with this visit, which comes to strengthen the close cooperation and permanent coordination between the Academy and the scientific and religious institutions and centers in Malaysia, especially the National Fatwa Council, which represents the first reference for fatwas in Malaysia, and the Department of Islamic Affairs of the Office of the Prime Minister of Malaysia, as well as the Malaysian Figh Society, which is also active in the field of jurisprudence studies and research.

For his part, His Excellency the Secretary General of the Academy expressed to His Excellency the Minister his sincere thanks and appreciation for the warm welcome, praising in this regard the appreciated efforts made by the Minister for the advancement of the religious institutions in Malaysia. He also assured the minister of the Academy's full readiness to make



strategic partnerships between the two sides, through the joint organization of conferences, seminars and discussion groups, preparation of studies, publication & translation of scientific research, as well as the exchange of publications, visits, and scientific meetings. And to achieve this, the two sides agreed to sign a memorandum of understanding between them on Wednesday, May 19, 2021.

At the end of the meeting, His Excellency the Minister asked His Excellency the Secretary General of



the Academy to make a television interview about the importance of taking vaccines against Covid 19, and explain the ruling of the Sharia regarding the extent to which this is permissible, based on the resolution issued by the General Secretariat of the Academy in this regard, in which it confirmed the permissibility of taking vaccines from a Shariah point of view, and that it is permissible for the ruler to put this in force for the general public interest, based on the rule agreed upon between scholars of jurisprudence: The Ruler's actions towards his subjects, are in the general public's interest. It has indeed become clear today that there is no room for doubt that there is a real and clear interest in taking vaccines against Covid 19, as it has been clinically proven to be of great efficiency and great benefit in preventing the Corona pandemic, and therefore Muslims around the world are encouraged to take the available vaccinations to preserve their lives and the lives of those around them.

#### IIFA and Islamic Development Bank (IsDB) sign a Cooperation Agreement

His Excellency Professor Koutoub Moustapha Sano, the Secretary General of the International Islamic Fiqh Academy, signed on Sunday 20 Ramadan 1442 corresponding to May 2, 2021, a cooperation agreement with His Excellency Dr. Bandar Hajjar, President of the Islamic Development Bank Group (IsD-BG), and as Director of the Endowment Properties Investment Fund.

The agreement aims to put in place the appropriate framework through which the contributions of the Academy are received and managed according to the policies and regulations of the fund, whereby the bank, according to this agreement, undertakes the investment of those contributions as the owner of the Endowment Properties Investment Fund, which is a trust fund that aims to mobilize financial resources for the purpose of creating a financing mechanism to enhance and develop the properties of the endowments that have economic viability in the Organization of Islamic Cooperation (OIC) member states and Muslim societies in non-member states.

This agreement is considered a general framework for close cooperation between the two parties, and a strengthening of the existing partnership relations between the two institutions, as they are two important organs of the OIC.

His Excellency Dr. Bandar Hajjar delivered a speech



on this occasion in which he spoke about the economic and financial implications of the Corona pandemic on the whole world, and praised the efforts made by the International Islamic Figh Academy in the field of promoting moderation and solidarity among all peoples, expressing his happiness with the good and solid relationships between the IIFA and the IsDBG. His Excellency also pointed out the great role played by the Endowment Properties Investment Fund in order to ensure the sustainability, financial independence, and social development of charitable organizations and in order to strengthen the non-profit sector.

On his part, His Excellency Prof. Koutoub Mousta-

pha Sano expressed his happiness with the occasion, which comes as a culmination of the negotiations the two parties held for months, and also expressed his sincere thanks and appreciation to His Excellency Dr. Bandar Hajjar for the successful development activities carried out by the bank under his leadership within the member states of OIC, commending in this regard the impressive success of the bank's Endowment Properties Investment Fund, and praising the importance of supporting this fund at all levels. His Excellency concluded his speech by inviting His Excellency Dr. Bandar Hajjar to mediate with the Islamic financial institutions that the bank deals with in order to support the Endowment Fund of the International Islamic Figh Academy.

It is worth mentioning that the IIFA Endowment Fund was established by a decision of the Ministerial Council of Foreign Ministers of the OIC Member States in 2017 in the Republic of Côte d'Ivoire in order to become the fixed financial resource for financing the activities and programs of the Academy from its proceeds and revenues. The fund seeks to collect a capital of two hundred fifty (250) million US dollars from donations and grants coming from the governments of the member states of the OIC and from charitable institutions and individuals from Muslim peoples around the world.

eral meanings contained in the thirty verses of the great Surat Al-Mulk. His Excellency Prof. Koutoub Sano, on his part, highlighted in his speech the importance of knowing the reasons of the revelation of the verses, and the social contexts behind them. It happens that the polytheists decided to use secrecy when talking about the Messenger of God, Peace Be Upon Him, wrongly believing that God would not know what they are saying and doing. Therefore, the Surah revealed indicating and confirming that God knows what they reveal and what they hide when they are badmouthing the prophet.

His Excellency also indicated the status of this surah and the benefit of reading it every night, and explained that it has several names, the most important of which are: Al-Munjiyah (the saviour), Al-Mani'ah (the preventor), Al-Waqiyah (the protector), and Al-Mujadilah (the arguer). It was called Munjiyyah because it saves its reader from the torment of the grave, and it is called Mani'ah because it prevents its reader from the

## The International Centre for Fatwa and Hala at the Malaysian Islamic Sciences University hosts H.E. Prof. Koutoub SANO's lecture entitled "Jurisprudence between Theory and Practice"

On Monday 28 of Ramadan1441 corresponding to May 10, 2021 during his working visit to Malaysia, His Excellency Professor Koutoub Moustapha Sano, Secretary General of the International Islamic Fiqh Academy, accepted the International Center for Fatwa and Halal's invitation to deliver a virtual lecture entitled: "Promoting Jurisprudence from the Perspective of the Academic Professor, Minister and Secretary General of the Academy." His Excellency began his lecture by shedding light on an important scientific milestone in his Academic career, which he started a quarter of a century ago as a lecturer, then an assistant professor, then an associate professor, then a professor, and indicated in the meantime that this period was characterized by the predominance of thinking, contemplation, reflection, and innovation. He focused his attention during this period on writing research, books, preparing studies and events, and participating in international scientific conferences and symposia around the world, noting that his vision of the outside world was at this stage an ideal one based on the belief in the possibility of achieving the desired reform and change easily and quickly and within a record period of time. He spent sixteen (16) years of his life in this period, which he described as the most stable psychologically, mentally, and socially. Then the second milestone was when he returned to his country as Minister of Religious Affairs, Minister of International Cooperation, then Minister at the Presidency for Diplomatic Affairs and Diplomatic Advisor to the President of the Republic.

His Excellency explained that this period also posed a challenge to him as he was searching for different ways and means to apply many Shariah rulings and teachings to the living reality in his country, whose constitution stipulates that it is a secular country that stands at the same distance from all religions and does not allow it to oblige people with the provisions of the Shariah, based on the principle of freedom of religions and beliefs. Hence, His Excellency emerged from this period with the belief



of the importance of starting from the Shariah objectives when trying to apply the Shariah rulings on social, political, economic, and intellectual realities, and he also strongly believes of the utmost importance to start from a number of the purposes of revelation, especially taking into account progress and balance between good and evil. His Excellency spent twelve (12) years in the aforementioned ministries, and he tried hard to carry out a number of reforms in many vital areas such as strengthening the relations of cooperation, partnership and friendship between his country and countries of the Islamic world. He has also developed the performance of ministries, highlighting the fact that mastery, creativity, transparency, productivity, and innovation are essential features of management and reform. He also sought to change perceptions about the relationship between religion with politics, and about the ability of intellectuals with a religious culture to hold higher ministerial positions.

Then His Excellency spoke about the current milestone that he started months ago in his capacity as Secretary General of the International Islamic Fiqh Academy, which is, in fact, a scientific, intellectual and political institution that combines the two previous milestones, and requires a sophisticated combination of thought and management, and politics, and a reconciliation between theory, application and practice through political and scientific institutions inside and outside the Islamic world, given that the Academy is a scientific reference to which the member states of the Organization of Islamic Cooperation and Muslim societies all over the world resort to in order to clarify the Shariah rulings on issues that concern them.

He emphasized that he is continuing to benefit from the first two milestones for the sake of advancing this institution and promoting it among the world's leading scientific institutions capable of shaping thought, giving opinion, and rationalizing practice in total harmony and integration between jurisprudence, application, and practice.

His Excellency concluded his lecture by stressing the importance of the Jurist's involvement in the social, political, and economic life in order to bring about the required change and reform in an organized and well-planned manner taking into account priorities, and rules of progression. His Excellency then answered the questions and inquiries of the attendees, the most prominent of which was the response to the skeptics about the efficiency of the vaccines against Covid 19 based on the conspiracy theory, where His Excellency explained that questioning the effectiveness of these vaccines is nothing more than an adventure that the jurist should not be involved in, especially that doctors and scientists agree on its efficiency and its ability to prevent from Corona virus, and to reduce its impact in the event of infection, which means that it must be sought to combat this pandemic.

# IIFA Secretary General holds a consultative meeting with the Malaysian Figh Society "AFHAM"

His Excellency Professor Koutoub Moustapha Sano, Secretary General of the International Islamic Fiqh Academy (IIFA), held a meeting on Sunday 4 of Shawwal 1442 corresponding to 16 of May 2021 in Kuala Lumpur with members of the Malaysian Fiqh Society, also known as the Malaysian Islamic Fiqh Academy "AFHAM".

This virtual meeting was attended from the Malaysian side by Dr. Abdulmanan Ismail, Chairman of the Society and Dr. Irwan Mohamad Subri, its General Secretary, as well as a number of members of the Society's Executive Office. The meeting discussed ways to develop cooperation relations between the Academy and the Society and to enable it to make the most of the scientific and administrative expertise and capabilities of the Academy.




### IIFA Secretary General meets with the 14 Malaysian Muftis

At the beginning of the meeting, His Eminence Dato Wan Zahidi, Chairman of the National Committee for Revision (Fatwas), welcomed His Excellency the Secretary General of the International Islamic Fiqh Academy, and thanked him for accepting the committee's invitation. He also presented to His Excellency the members of the National Committee who represent the fourteen Malaysian states, and each member of them is considered Mufti of his own state. The committee also includes three other expert members.

Committee for Revision went through, explaining that this committee was until recently called the National Fatwa Council, and this name was changed to the National Committee for Revision in compliance with the desire of the Sultans of the states for each state to maintain its independence in fatwas and guidance, since the specialization of the committee to issue fatwas in pubic matters does not pertain to a specific state.

For his part, His Excellency Prof. Koutoub Moustapha SANO, Secretary General of the Academy expressed his sincere thanks and great appreciation to their eminence the muftis who represent their states for this first ever meeting of its kind, in order to discuss and debate about strengthening ways and aspects of cooperation

and communication between the Academy and the National Committee for Revision (Fatwas), especially with regard to coordination between the two parties in the field of fatwas, in cases that transcend borders and countries and concern Muslims all over the world. His Excellency also provided the participants with an extensive briefing on the Academy's history, vision, mission, goals and means, stressing in this regard that the Academy looks forward in the coming days to broader cooperation and closer communication with the National Committee in the fields of research, studies and fatwas, and the organization of training and qualification courses for members of the National Committee.

Moreover, the Academy will provide the Fatwa Centers at the different states in Malaysia with its publications, especially the fourth edition of the book of resolutions and recommendations. His Excellency also expressed the academy's readiness to provide intellectual and administrative support for all research and development projects that the National Committee intends to implement in the coming years, regarding the committee's desire to establish a Malaysian Fiqh Academy specialized in jurisprudence and Ifta issues.

# IIUM's Alumni Club hosts the Secretary General's lecture on Lessons from Covid-19

Within a series of scientific and intellectual lectures organized by Alumni of the International Islamic University in Malaysia, His Excellency Prof. Koutoub Moustapha SANO, Secretary General of the International Islamic Fiqh Academy, delivered a lecture on Friday 16 Shawwal, corresponding to May 28, 2021, entitled: "Lessons from the Covid-19: Five (5) opportunities that must be seized before it is too late.

His Excellency began his lecture by expressing his sincere thanks to the Club's managers for keeping in touch with the university's alumni, praising their commitment to promote the club through organizing intellectual and social activities and events. He also commended them for the efficient organization, arrangement and coordination of events and praised the accuracy of the intellectual topics that the club raises for discussion and study.

His Excellency then commented on the lecture's title, which he described as a good summary of a hadith (prophet saying) that carries within its folds a warning, advice, and reminder of those great blessings that Allah has bestowed on each of us in varying degrees. However, many of us do not make the most of these blessings that are eternal. As for the hadith, it is what the Prophet (Peace Be Upon Him) said to Abu Dharr Al-Ghifari:

"O Abu Dharr, take advantage of five before five: your youth before your old age, your health before your sickness, your wealth before your poverty, your free time before your busyness, and your life before your death". The scholars consider this hadith as one of the most important sayings and a clear proof of his prophecy due to the simplicity of its content, yet the consistency with what Allah grants to all of us in various degrees. These five blessings represent the grace of youth, the grace of health, the grace of wealth, the grace of free time, and the grace of life. These graces are not eternal, which makes it wise of any man to seize them and benefit from them to the maximum in accordance with



God's commandments and his intent for man on earth; therefore, in order to benefit from them, it is necessary to exploit them in obedience to Allah and His Messenger (PBUH) in order to fulfil the mission of God's vice-regency on earth, to build the earth in accordance with the divine teachings, and to work for good deeds that include all aspects of intellectual, scientific, social, economic, political, cultural, and educational life.

His Excellency also explained that the Corona pandemic has increased awareness of these graces and their importance, since the partial and total halt of economic activity that has affected many countries and cities in the world is a reminder of all these graces, especially those of health and free time. Unemployment and heavy losses suffered by individuals, companies and countries remind us of the grace of wealth, just as the quarantine imposed on people and companies, and the crowding of hospitals and health centers with sick

and dead people, remind us of the graces of health and life. As for the grace of youth, which calls for optimism, activity, planning, projects and hopes, it was also interrupted due to the restrictions on movement and traveling resulting from the pandemic.

Therefore, we should all contemplate these graces and seize them before their disappearance by avoiding procrastination, delay and relying on a future that is not under our control. Therefore, our young people must use their age, strength, and energy to equip themselves with knowledge and all types of know-how. It is time for them to make the most of this temporary grace before it disappears. In fact, we must all exploit these graces for what is beneficial for us, our societies, and our countries.

His Excellency concluded his lecture by invoking Allah to hasten the disappearance of this pandemic from the Ummah, to accept those who perished into the gardens of his paradise, and for the speedy recovery of the sick.

Then, His Excellency answered the questions raised by the audience, especially regarding the call to Muslims and the world to seek forgiveness, repentance and return to Allah, to honor our parents and next of kin, to increase charitable work, to be good and to show kindness to the poor, the needy and the vulnerable all over the world. He also called upon Muslims to comply with the health authorities' precautionary measures in their countries to protect themselves and people around them.

It is worth noting that the Alumni Club of the International Islamic University Malaysia plays a role in following the graduates' achievements in their professional lives after graduation. In addition, the Alumni Club organizes an annual conference to honor outstanding graduates who have made significant achievements and impact on their society and country.


H.E. Prof. Koutoub Moustapha SANO, Secretary General of the International Islamic Fiqh Academy, delivered on Sunday, 13 Ramadan 1442, corresponding to 25 April 2021 a virtual Ramadan lecture entitled "Ramadan and Corona: Best Practices" as part of the Ramadan lectures hosted by the World Council of Muslim Communities in Abu Dhabi, United Arab Emirates.

His Excellency began his lecture with thanks and praise for the good efforts

of the World Council of Muslim Communities under the leadership of its Chairman Dr. Ali bin Rashid Al Nuaimi and its Secretary General, Dr. Muhammad Al-Bashari, through valuable intellectual lectures and seminars for the benefit Muslims worldwide and that contribute to the renewal of Islamic thought and the consolidation of the concepts and values such as moderation, dialogue, tolerance, and religious, ethnic, and cultural pluralism.

His Excellency then referred to the current unprecedented and challenging situation through which humanity is living under the repercussions of the Corona pandemic, which has deeply affected our daily life and practices. Hence, moderation is one of the best practices during the month of Ramadan, the month of moderation in all that we do, particularly when eating, drinking and sleeping. In other words, it is, in fact a month of worship and

not a month of extravagance in eating; therefore, we have to spend more of what we have on the poor and the needy who are desperate for our assistance to alleviate the burden of poverty from them. His Excellency also stressed that Ramadan is the month of increasing our worship and good deeds, so a Muslim should take advantage of this holy month to spend most of his or her time in prayers, supplication, reading the Qur'an and do-

ing righteous deeds instead of long hours of laziness and sleep.

His Excellency also warned against some harmful behaviors such as excessive anger, arguments, and fighting during this holy month, in which we must instead be patient with everyone and treat them all with love and kindness. He also encouraged good practices such as social visits, especially visiting parents, to obtain their blessings with total commitment and observance of health safety requirements.

In conclusion, His Excellency affirmed the need to seize the opportunity of this holy month to change for the better, to reform our behaviors and practices, treat everyone and ourselves with kindness, and to pray to Allah to remove this pandemic and keep its scourge away from us and also pray for goodness, peace and security to prevail among all human beings.

#### Mohammed Bin Zayed University for Humanities in Abu Dhabi invites H.E. Prof. Koutoub Moustapha SANO to deliver a lecture on the values of love in the Holy Quran

At the invitation of the Mohammed bin Zayed University for Humanities in the Emirate of Abu Dhabi, United Arab Emirates, H.E. Professor Koutoub Moustapha SANO, Secretary General of the International Islamic Fiqh Academy, delivered a lecture entitled: Values of Love in the Holy Quran.

His Excellency began his lecture by expressing his sincere thanks and appreciation to His Excellency Dr. Hamdan Musallam Al Mazroui, Chairman of the University's Board of Trustees, and to His Excellency Dr. Khaled Al Dhaheri, the University President for his invitation to deliver this lecture as part of a series of religious lectures on the grand values in the Holy Qur'an. He also thanked the faculty members and students for their attendance and active participation.

Then His Excellency spoke about the importance of the topic of the lecture – love-, considering that it is the basis of faith, the key to paradise, the pillar of stability, the pillar of happiness and prosperity. It is ultimately the origin of the relationship between humans and their Lord, and between each other, as there is no happiness, safety, or stability without love.

His Excellency then indicated that the concept of the term love is determined by looking at the beloved and the lover, even if the origin of it is the tendency of the soul to what it sees and thinks it is good for it, referring in this regard to what the predecessors said that there are thirty concepts of love. Then His Excellency explained that the concept of a person's love for God and His Messenger, differs from the concept of a person's love for his parents, his children, and for relatives.

He explained that man's love for God means his obedience to Him, thanks to Him, praise for Him, compliance with His orders and avoiding His prohibitions, while His love for the parents, children and relatives means showing righteousness to them, benevolence to them and making them happy. As for the love of God for man, it means caring for him, preserving him, and protecting him from all harm, as mentioned in the Holy Quran:

"And I bestowed upon you love from Me, that you would be brought up under My eye [i.e., observation and care]" Taha: 39.

His Excellency explained that in the Holy Qur'an a noble verse referred to the ranks of love, and the importance of taking it into account when in doubt, which is the Almighty's saying:

"Say, [O Munammad], If your fathers, your sons, your brothers, your wives, your relatives, wealth which you have obtained, commerce wherein you fear decline, and dwellings with which you are pleased are more beloved to you than Allah and His Messenger and jihād [i.e., striving] in His cause, then wait until Allah executes His command. And Allah does not guide the defiantly disobedient people." At-Tawbah: 24.



Many scholars and researchers wrongly misinterpret this verse as a warning and a rebuke, but a closer look at it reveals that it refers to the levels and types of love and is a clear legislation that the Muslim should refer to in order to differentiate between the types of loved ones.

In fact, the verse acknowledges two types of love: An innate and natural love, and the second is an optional and acquired love, and the verse shows the types that fall under the first type of love, namely: love of origins (fathers and grandfathers), love for off springs (children and grandchildren), love for the first kinship (brothers and sisters), love for spouses (in-laws) and love for the clan (Tribes and human society), love of money (in-kind and cash), love of professions (trade, agriculture, and industry) and love of dwellings (homes, villas, and palaces).

This love is natural and innate in us, we do not learn it but rather we learn how to tame it and make it moderate. As for the second type of love, it is represented in the love of God, the love of His Messenger, and the love of jihad [i.e., striving] for the sake of God. This kind of love is optional and acquired because a person acquires and chooses it through his struggle and hard work.

Therefore, this love is the one that must come before all kinds of love, in the belief that it is love for the greatest and most beloved. More precisely, if any love conflicts with this love, then it must be preceded unreservedly, as is the case in the obligation to put first the love for God over the love for our parents, children, wives, wealth, professions, and business.

His Excellency then mentioned that the Holy Qur'an called upon the believers to acquire the love of types of good deeds and actions that would increase their feelings of happiness, security, and stability. We find them especially in the love of repentance (he loves the repentant), the love of piety (he loves the pious), the love of justice (he loves the just), and the love of purity (He loves the purified ones), the love of patience (he loves the patient), the love of trust (he loves

those who trust in Him), and the love of charity (he loves the benefactors).

His Excellency touched on highlighting the integral relationship between love and affection on the one hand, and between love and cordiality on the other hand, as he emphasized that affection is higher and more general than love, as affection is an advanced stage of love if it is mixed with tenderness, compassion, and mercy then it becomes affection. As a result, the Beloved is not one of God's names but the Compassionate is, which affirms that affection is greater and higher than love. Therefore, every affection is love, and not all love is affection. The noble Lord, moreover, urged that the relationship between the spouses should rise to the stage of affection and mercy given the importance of this relationship as the cornerstone of society.

His Excellency added that God the Almighty indicated that the ideal relationship that should prevail among the followers of what is known today as the Abrahamic religions should be affection rather than love, a confirmation of the value of affection and its importance for happiness, stability, security, and safety for all humanity.

At the end of his valuable lecture, His Excellency reiterated his call for researchers and scholars to give more attention and care to the topic of love in the Holy Qur'an and the Noble Sunnah, in order to enable the young generations to absorb its complex meanings, understand its themes, and ultimately acquire its values.

Finally, His Excellency Dr. Hamdan Musallam Al Mazroui deeply thanked the honorable speaker and made a distinguished comment on the lecture, in which he added another type of love which is the love for our homeland and the love and obedience to our rulers.

The lecture was well received and welcomed by the participants.

Commenting on the discussions and deliberations, His Excellency Prof. Koutoub SANO explained that the information contained in the training package is sufficient and suitable, but it needs reformulation and re-arrangement of the proposed scientific courses to become suitable for preparing an Islamic banking manager who is familiar with the most important



Sharia rules governing Islamic banking sector, and the general basics of planning, development, management, and leadership.

His Excellency also proposed that the Council communicate again with the developer of the training package in order to consider the proposed technical comments and allow him enough time to improve the scientific content of the package to make it more accurate and focused. His Excellency also talked about the importance of matching the titles of the proposed

topics and the scientific vocabulary contained in the training package, stressing in this regard the need to use the vocabulary to prepare a distinguished Islamic banking manager.

Again His Excellency suggested that it is sufficient to just study the five universal rules of Figh without the need to go into too many details in order to avoid confusion and misunderstandings. The meeting then discussed the report on the portfolios of Sharia auditing and the specialized certificates related to it such as the accredited Islamic Certificate in Sharia auditing, the advanced Islamic Certificate in Sharia auditing, and the professional diploma in auditing. At the end of the meeting, the participants reviewed the CVs of the proposed trainers, and His Excellency called on the Council to verify the scientific accreditations of the trainers, and to make specialization in Islamic finance and banking the main criterion when selecting candidates, in addition to work experience. Secretary General of the Council concluded the meeting by thanking the honorable attendees for the participation and discussions aimed at improving and developing the Islamic finance and banking sector.
