#### Qatar Hosts the 26th Session of the Council of the International Islamic Figh Academy



Under the esteemed patronage of His Excellency Sheikh Mohammed Abdulrahman Al Thani, Prime Minister and Minister of Foreign Affairs of the State of Qatar, the 26th session of the Council of the International Islamic Figh Academy (IIFA), a subsidiary organ of the Organization of Islamic Cooperation (OIC), officially opened on Sunday, 6 Dhu al-Qi'dah 1446H, corresponding to 4 May 2025, in Doha, Qatar. The proceedings began with a recitation from the Holy Qur'an, followed by a welcoming address delivered by His Excellency Mr. Ghanem bin Shaheen Al Ghanim, Minister of Awqaf and Islamic Affairs, who warmly welcomed the participating scholars and experts from across the Muslim world. In his address, His Excellency underscored the importance of Qatar's hosting of this prominent scholarly event, affirming that Islamic law offers comprehensive guidance on matters that concern humanity. He further highlighted the Academy's pivotal role in addressing contemporary juristic issues, serving as a leading intellectual platform that unifies perspectives and amplifies the collective voice of the Islamic world.

His Excellency Mr. Hussein Ibrahim Taha, Secretary General of the Organization of Islamic Cooperation, also addressed the gathering, commending the Academy for its role in promoting collective Ijtihad and providing jurisprudential responses to the pressing challenges of the Ummah. He lauded Qatar's significant contributions to advancing joint Islamic action under the wise leadership of His Highness Sheikh Tamim bin Hamad Al Thani, Emir of the State of Qatar, and his esteemed government.

#### Speech by His Excellency Sheikh Dr. Saleh bin Abdullah bin Humaid President of the Academy

On behalf of the Council of the International Islamic Fiqh Academy—and in my personal capacity—it gives me great honor and pleasure to extend the warmest welcome to you all on the occasion of the opening ceremony of the 26th session of the Council, graciously hosted in the city of Doha by the Ministry of Awqaf and Islamic Affairs of the State of Qatar.

This blessed gathering stands as a powerful testament to the unwavering dedication of our distinguished scholars and members to the noble responsibility of conveying religious guidance—an obligation entrusted to the scholars of this Ummah by Almighty Allah, who said:

"Indeed, Allah took a covenant from those who were given the Scripture, [saying], 'You must make it clear to the people and not conceal it.'" (Aal 'Imran: 187)

The practice of Ijtihad, as a disciplined intellectual effort to derive legal rulings for emerging challenges, has always been the path of the rightly guided jurists. Allah Most High states:

"When there comes to them news of [public] security or fear, they spread it around. But if they had referred it to the Messenger or to those of authority among them, the ones who can draw correct conclusions would have known

it."(AnNisa: 83)

And He says:

"So take warning, O people of vision."(AlHashr:2) And:

"Consult them in matters." (Aal 'Imran: 159)
Inspired by these divine injunctions, this session convenes to examine critical contemporary matters requiring collective Ijtihad, with the aim of harmonizing scholarly reasoning with specialized expertise and bridging the divide between legal theory and real-world application. Through Allah's grace, we aspire to produce insightful and actionable resolutions that reflect the realities of our age and uphold the principles of our faith.

This session takes place amid profound and accelerating global transformations—transformations that touch the very fabric of family life, demand scientific reassessments of food and medicine policies, call for strengthened models of governance, and challenge us to consider how Islamic finance can address today's complex economic realities. The inclusion of such themes in this session underscores the allencompassing nature of Islam and its enduring capacity to offer genuine, principled, and forward-looking solutions.

Now more than ever, the Ummah needs a vibrant, institutionalized framework of collective Ijtihad that fosters innovation within the parameters of Shariah and leverages scientific and intellectual advances for the benefit of all humanity. It gives rise to new jurisprudential insights that benefit scholars, students, and institutions alike. Therefore, it is imperative that all submissions to the Academy remain anchored in this coherent methodological vision. Any departure from it risks inconsistencies in legal analysis and undermines the credibility of conclusions.

Indeed, Fiqh academies—and their collective deliberations—stand at the forefront of applying Islamic legal principles to the ever-changing realities of our world. Their resolutions play a pivotal role in enriching jurisprudential discourse, supporting fatwa bodies, guiding judicial systems, and informing national legislation, thanks to the soundness of their methodology and the strength of their evidentiary basis.

Among the most important topics on the agenda of this session are:

Child Welfare, Artificial Intelligence, the Principle of Istishab (presumption of continuity), Electronic Games, Mental Health, Islamic Finance, and Shariah Governance.

In addition, this session will review the outcomes of recent specialized scientific symposia held by the Academy on key developments in the halal industry, with a view to issuing clear and practical resolutions.

Prof. Sano concluded by offering heartfelt gratitude to the State of Qatar—its leadership and people—for their warm hospitality and facilitation of all arrangements needed to successfully host this session. He also thanked the Ministry of Awqaf and Islamic Affairs, under the leadership of H.E. Mr. Ghanem bin Shaheen Al-Ghanem, for its exemplary coordination and support.

The Bureau then proceeded to discuss its agenda items, which included:

Approval of the minutes of the previous Bureau meeting;

A briefing on the memoranda of understanding signed by the General Secretariat of the Academy with various religious and academic institutions across OIC member states during the period between Jumada al-Akhirah and Dhul Qi'dah 1446 AH;

Review of nominations submitted by member states for new representatives to the Academy's Council;

A financial report on contributions made by member states to the Academy's budget for the current year

Among the resolutions adopted, the Bureau approved the nomination of the representative from the People's Republic of Bangladesh to the Council of the Academy. It also approved the appointment of Dr. Khawla Al-Nobani as a member of the Academy—making her the first woman in the history of the Academy to hold a seat on its Council.



## Figh Novelties and Contemporary Issues Discussed on Second Day of the 26th Session



On Monday, 7 Dhul Qi'dah 1446 AH, corresponding to 5 May 2025, the second day of the 26th session of the Council of the International Islamic Fiqh Academy (IIFA) featured five enriching and specialized academic plenary sessions.

These sessions addressed a range of pressing contemporary issues and developments that affect the daily lives of Muslims across various domains, including childcare, technology, economics, and legal reasoning (Ijtihad). A distinguished assembly of scholars, jurists, and subject-matter experts from within and beyond the Muslim world participated in the discussions.

The first plenary session focused on emerging challenges in childcare, with a particular emphasis on safeguarding children from abuse, bullying, and neglect—whether familial or institutional—in the face of rapid social and digital transformations. The discussions underscored the vital role of parental education and the shared responsibility of families, educators, and communities in raising children holistically, ensuring the protection of their faith, mental





health, and rights.

The session also examined digital safety for children in cyberspace, highlighting the urgent need to establish ethical and Shariah-based frameworks to govern children's interaction with modern technologies. Furthermore, the session addressed critical issues such as drug abuse and the excessive use of electronic games—two of the most alarming threats to childhood today—while presenting pioneering initiatives that reflect a balanced Islamic perspective on prevention and rehabilitation.

The second plenary session explored Istishab (presumption of continuity) as a foundational and recognized source of Islamic jurisprudence. Scholars analyzed its potential for deriving legal rulings in new and unprecedented matters where direct scriptural evidence is absent.

Participants highlighted Istishab as a stabilizing tool in Islamic legal theory, particularly useful in fields such as financial transactions, social relations, and medical ethics. Emphasis was placed on the need to apply this principle within clear methodological boundaries to ensure alignment with the higher objectives (maqasid) of Shariah and to avoid misuse or misinterpretation.

The third plenary session delved into the ethical and legal dimensions of artificial intelligence (AI), examining its far-reaching implications for sectors including healthcare, education, finance, and communication. Scholars and experts raised concerns regarding responsibility for algorithmic errors, data privacy, bias in algorithms, and the manipulation of information.

The discussions called for the development of a clear jurisprudential framework to regulate the use of AI in ways that preserve



human dignity and prevent the subjugation of moral and religious values to technological dominance. Participants recommended the formulation of a Shariah-compliant ethical code for AI deployment in the Muslim world. The fourth plenary session addressed contemporary issues in Islamic finance, a field witnessing rapid expansion and increasing complexity with the emergence of innovative financial instruments.

Key topics included the Shariah ruling on a third party adding an extra amount to a loan and its implications for the legal characterization of the loan contract. The session also examined the permissibility of charging fees for letters of guarantee and documentary credits—two common mechanisms in international trade. Case studies from Islamic financial institutions were shared, reinforcing the imperative to uphold Shariah principles of justice, transparency, and the prohibition of riba (usury) and gharar (excessive uncertainty).

At the conclusion of the day, the Academy's Council issued a series of significant resolutions and recommendations on these contemporary topics. These outcomes are expected to inform decision-making within relevant institutions across OIC member states and to strengthen the role of institutional collective Ijtihad in addressing the multifaceted challenges facing the Muslim Ummah today.





## On Its Third Day, 26th Session of IIFA Examines E-Games, Mental Health and Legal Capacity, Shariah Financial Governance, and Halal Industry Challenges



On Tuesday, 8 Dhul Qi'dah 1446 AH, corresponding to 7 May 2025, the 26th session of the International Islamic Figh Academy (IIFA), held in Doha, Qatar, continued with a series of in-depth scholarly discussions addressing contemporary jurisprudential issues of significant relevance to Muslim societies. The fifth plenary session was dedicated to the phenomenon of electronic games. Participants assessed the global prevalence of this rapidly expanding industry, acknowledging its educational and cognitive benefits, such as enhanced critical thinking, problem-solving, and teamwork skills. However, they also raised concerns regarding the adverse psychological, social, behavioral, and financial effects associated with excessive gaming, particularly among youth. The discussions were framed within key Shariah maxims, notably "bringing benefits and warding off harms" and "permissibility is the original state in benefits, and prohibition is the default in harms." Preventive measures rooted in family and educational institutions were proposed, alongside encouragement for developers to design games that align with Islamic ethical values and cultural norms.

The sixth plenary session explored the impact of mental health conditions on legal capacity. Scholars distinguished between "mental illnesses" and "psychological disorders" in accordance with international



medical classification standards, noting that psychological disorders refer to clinically significant patterns affecting cognition, mood, or behavior, which impair social and professional functioning. Guided by the Shariah objectives of preserving intellect ('aql) and life (nafs), the session emphasized that legal capacity should be assessed based on one's ability to perceive and discern. Scholars advocated for enhanced collaboration between Shariah councils, mental health professionals,



and judicial authorities to ensure nuanced, compassionate, and scientifically grounded Shariah-based approaches to these complex and sensitive matters.

The seventh plenary session focused on Shariah governance within Islamic financial institutions. The session stressed the necessity of establishing robust internal supervisory mechanisms to ensure full compliance with Shariah principles. Participants emphasized the importance of harmonizing Shariah reference points across institutions and cautioned against inconsistencies in the application of Islamic rulings, which can lead to market instability and conflicting fatwas. Scholars called on financial institutions to adhere to collective resolutions issued by recognized bodies, particularly the International Islamic Figh Academy and the Accounting and Auditing Organization for Islamic Financial Institutions (AAOIFI). It was

affirmed that the Academy's resolutions should serve as binding Shariah references across the Islamic financial sector. Participants also addressed challenges facing internal Shariah boards, including external pressures to conform to administrative directives that may contradict Shariah rulings. Calls were made for greater autonomy and institutional empowerment of these boards to safeguard their credibility and independence.

The eighth plenary session examined emerging jurisprudential questions in the halal industry. The session presented outcomes from specialized medical and juristic symposia organized by the Academy's Secretariat General. Key topics included the permissibility of stunning animals and birds before slaughter. Scholars distinguished between methods that result in death prior to slaughter—which is categorically forbidden—and those that mitigate pain without causing death, which may be permitted.

Further deliberations addressed the permissibility of feeding premature infants with breast milk donated by identified or anonymous women, with attention to the legal implications of rada'ah (nursing) on kinship ties. Scholars stressed the importance of proper documentation to preserve lineage and uphold Shariah principles.

Additional discussions focused the jurisprudential rulings related the production and marketing of lab-grown meat and genetically modified animal products, including those derived from insects. These debates incorporated scientific and juridical considerations of Istihala (transformation of substance), essential change, public health, and societal acceptance. Participants underlined the need to apply strict standards for certifying products as halal, ensuring that all Shariah conditions are fully and consistently met.



## Academy Council Endorses Landmark Declarations Previously Issued by OIC and MWL



As part of the proceedings of the 26th session of the International Islamic Fiqh Academy (IIFA), held in Doha, State of Qatar, His Excellency Dr. Abdulrahman Al-Zaid, Deputy Secretary General of the Muslim World League (MWL), delivered a keynote address in which he presented two significant foundational documents issued by the MWL: the "Makkah Declaration" and the "Document on Building Bridges Between Islamic Schools of Thought." He highlighted their profound intellectual, religious, and humanitarian content, which calls for the strengthening of Islamic unity, the promotion of tolerance and peaceful coexistence, and



the rejection of extremism, division, and sectarianism.

Dr. Al-Zaid emphasized that the Makkah Declaration—endorsed in 2019 by over 1,200 scholars and intellectuals from 139 countries during an Islamic conference convened by the MWL—serves as a comprehensive Islamic civilizational charter. It articulates a unified vision of relations among Muslims and between Muslims and others by upholding principles of equal citizenship, respect for doctrinal and intellectual diversity, and the rejection of hate speech and racial discrimination. The declaration also stresses the protection of places of worship, the defense of women's and children's rights, and

the rejection of any exploitation of religion in political conflicts.

As for the Document on Building Bridges Between Islamic Schools of Thought, it reinforces the same goals through a scholarly and practical framework for rapprochement between different Islamic schools. The document advocates for the creation of an ongoing platform for dialogue among scholars and institutions of the Ummah, grounded in mutual respect for legitimate differences, prioritization of shared values, and protection of Muslim societies from sectarian conflict and the politicization of religious identity. Dr. Al-Zaid called on the Academy to formally adopt these historic declarations and encouraged activating their content through academic collaboration and educational outreach.

Following this presentation, Ms. Sarah bint Amjad bin Hussein Bedewi, Director of the Department of Family, Women, Youth, Children, and the Elderly at the Academy, delivered a comprehensive address on the "Women's Declaration: Status and Empowerment," issued by the Organization of Islamic Cooperation (OIC) in collaboration with IIFA. This declaration is widely regarded as one of the most important contemporary references on women's rights in Islam.

In her address, Ms. Sarah outlined the core themes of the declaration, which reaffirm the inherent dignity of women and their rights to education, employment, participation in public life, and legal and social protection—all within the framework of Islamic values and Shariah objectives. The document also highlights the importance of empowering women in decision-making roles, enhancing

their contributions to development, and confronting all forms of discrimination and violence against them.

She further addressed the challenges faced by Muslim women in some societies, emphasizing that the declaration serves as a balanced legal and intellectual reference that upholds women's rights without compromising religious principles. Ms. Sarah urged wider dissemination of the declaration, its integration into educational curricula and academic programs, and reinforced collaboration with legislative and executive authorities to translate its contents into actionable policies.

The participating scholars and experts praised the three declarations for their enlightened and contemporary Islamic vision. They commended their emphasis on moderation, family cohesion, and doctrinal and intellectual unity within the Ummah. Participants called for enhanced coordination between the Academy and relevant institutions to ensure effective implementation of the declarations at all levels, thereby supporting the progress and stability of Muslim societies.

#### 26th Session Concludes with Tribute to the Founding Members



The 26th session of the Council of the International Islamic Fiqh Academy (IIFA) concluded on Thursday, 8 May 2025, at the Ritz-Carlton Hotel in Doha, under the patronage of His Excellency Sheikh Mohammed bin Abdulrahman bin Jassim Al Thani, Prime Minister and Minister of Foreign Affairs of the State of Qatar.

Over five days of deliberations, the session brought together leading scholars, jurists, and experts from across the Muslim world for rigorous academic discussions on pressing contemporary issues facing the Ummah.

The closing ceremony commenced with an address by His Excellency Datuk Dr. Sirajuddin Suhaimee, Director-General of the Department of Islamic Development Malaysia (JAKIM). He conveyed the greetings of Honourable Dato Seri Anwar Ibrahim, Prime Minister of Malaysia, to the distinguished scholars of the Ummah, and praised the Academy's pivotal role in institutionalizing the methodology of collective Ijtihad, fostering intellectual integration, and promoting the values of tolerance and openness. He concluded by

announcing Malaysia's readiness to host the 27th session of the Academy.

This was followed by a presentation from

Academy, delivered the OIC Women's Declaration, reaffirming the central place of women's dignity, empowerment, and rights within the framework of Islamic law.

His Excellency Sheikh Dr. Thaqil bin Sayer Al-Shimari, Vice President of the session, then presented a detailed summary of the resolutions and recommendations adopted by the Council. These addressed a wide range of contemporary challenges affecting the social, economic, psychological, and financial well-being of Muslim communities, including child protection, electronic gaming regulations, artificial intelligence, Shariah governance of Islamic financial institutions, genetically modified foods, and the stunning of animals prior to slaughter.

In his address, His Excellency Professor



His Excellency Dr. Abdul Rahman Al-Zaid, Assistant Secretary General of the Muslim World League, who revisited the key principles of the Makkah Declaration and the Charter on Building Bridges Between Islamic Schools of Thought. Subsequently, Mrs. Sarah bint Amjad bin Hussein Bedewi, Director of the Department of Family, Women, Children, and the Elderly at the

Koutoub Moustapha Sano, Secretary General of the Academy, read the Council's Statement on Occupied Palestine, with specific reference to the genocide and systematic starvation taking place in Gaza. He strongly condemned these acts as grave violations of fundamental human rights and the principles of Islamic law.

The session concluded with a moment of solemn reflection and recognition, as the Academy honored its founding members—those scholars and experts who participated in the inaugural session in 1983. These pioneers were acknowledged for their foundational role in establishing the Academy and laying the cornerstone of collective Ijtihad, a principle that continues to shape the Academy's legacy and impact.
